
January 2019 compared with December 2018

Volume of retail trade up by 1.3% in euro area

Up by 1.1% in EU28

In January 2019 compared with December 2018, the seasonally adjusted volume of retail trade increased by 1.3% in the **euro area** (EA19) and by 1.1% in the **EU28**, according to estimates from **Eurostat, the statistical office of the European Union**. In December, the retail trade volume decreased by 1.4% in the **euro area** and by 1.3% in the **EU28**.

In January 2019 compared with January 2018, the calendar adjusted retail sales index increased by 2.2% in the **euro area** and by 2.5% in the **EU28**.



Monthly comparison by retail sector and by Member State

In the **euro area** in January 2019, compared with December 2018, the volume of retail trade increased by 1.7% for non-food products, by 1.6% for automotive fuel and by 0.6% for food, drinks and tobacco. In the **EU28**, the retail trade volume increased by 1.5% for non-food products, by 1.2% for automotive fuel, and by 0.8% for foods, drinks and tobacco.

Among Member States for which data are available, the largest increases in the total retail trade volume were registered in **Germany** and **Malta** (both +3.3%), as well as in **Estonia** and **Romania** (both +1.9%). Decreases were observed in **Finland** (-2.1%), **Slovenia** (-1.0%), **Denmark** and **Austria** (both -0.7%), and **Belgium** (-0.4%).

Annual comparison by retail sector and by Member State

In the **euro area** in January 2019, compared with January 2018, the volume of retail trade increased by 4.3% for automotive fuels, by 2.2% for food, drinks and tobacco and by 1.7% for non-food products. In the **EU28**, the retail trade volume increased by 4.4% for automotive fuel, by 2.4% for food, drinks and tobacco and by 2.3% for non-food products.

Among Member States for which data are available, the highest yearly increases in the total retail trade volume were registered in **Slovenia** (+11.0%), **Ireland** (+8.1%) and **Romania** (+6.7%). Decreases were observed in **Finland** (-1.3%), and **Denmark** (-0.3%).

Geographical information

The **euro area** (EA19) includes Belgium, Germany, Estonia, Ireland, Greece, Spain, France, Italy, Cyprus, Latvia, Lithuania, Luxembourg, Malta, the Netherlands, Austria, Portugal, Slovenia, Slovakia and Finland.

The **European Union** (EU28) includes Belgium, Bulgaria, Czechia, Denmark, Germany, Estonia, Ireland, Greece, Spain, France, Croatia, Italy, Cyprus, Latvia, Lithuania, Luxembourg, Hungary, Malta, the Netherlands, Austria, Poland, Portugal, Romania, Slovenia, Slovakia, Finland, Sweden and the United Kingdom.

Methods and definitions

The **index of the volume of retail trade** measures the evolution of the turnover in retail trade, adjusted for price changes (deflated), i.e. the evolution of the total amount of goods sold, based on data adjusted for calendar and seasonal effects.

Seasonally adjusted euro area and EU series are calculated by aggregating the seasonally adjusted national data. Eurostat carries out the seasonal adjustment of the data for those countries that do not adjust their data for seasonal effects.

Missing observations from Member States for recent months are estimated for the calculation of the euro area and the EU aggregates.

Revisions and timetable

Data of previous months have been revised compared to those issued in the News Release [24/2019](#) of 5 February 2019. The monthly percentage changes for December 2018 have been revised from -1.6% to -1.4% in the euro area and from -1.4% to -1.3% in the EU28. The annual percentage changes have been revised from +0.8% to +0.3% in the euro area and from +1.2% to +0.9% in the EU28.
