



February 2019 compared with January 2019

Volume of retail trade up by 0.4% in both euro area and EU28

In February 2019 compared with January 2019, the seasonally adjusted volume of retail trade increased by 0.4% in both the **euro area** (EA19) and **EU28**, according to estimates from **Eurostat, the statistical office of the European Union**. In January, the retail trade volume increased by 0.9% in the **euro area** and by 1.0% in the **EU28**.

In February 2019 compared with February 2018 the calendar adjusted retail sales index increased by 2.8% in the **euro area** and by 3.3% in the **EU28**.



Monthly comparison by retail sector and by Member State

In the **euro area** in February 2019, compared with January 2019, the volume of retail trade increased by 0.9% for non-food products and by 0.1% for food, drinks and tobacco, while automotive fuel decreased by 0.7%. In the **EU28**, the retail trade volume increased by 1.0% for non-food products, while food, drinks and tobacco decreased by 0.1% and automotive fuel by 0.2%.

Among Member States for which data are available, the largest increases in the total retail trade volume were registered in **Croatia** (+4.4%), **Belgium** and **Latvia** (both +1.6%). The largest decreases were observed in **Slovakia** (-1.5%), **Portugal** (-1.0%) and **Bulgaria** (-0.6%).

Annual comparison by retail sector and by Member State

In the **euro area** in February 2019, compared with February 2018, the volume of retail trade increased by 4.4% for non-food products, by 1.6% for automotive fuels and by 0.6% for food, drinks and tobacco. In the **EU28**, the retail trade volume increased by 5.1% for non-food products, by 3.0% for automotive fuel and by 1.0% for food, drinks and tobacco.

Among Member States for which data are available, the highest yearly increases in the total retail trade volume were registered in **Slovenia** (+11.8%), **Croatia** (+11.4%) and **Romania** (+9.1%).

Geographical information

The **euro area** (EA19) includes Belgium, Germany, Estonia, Ireland, Greece, Spain, France, Italy, Cyprus, Latvia, Lithuania, Luxembourg, Malta, the Netherlands, Austria, Portugal, Slovenia, Slovakia and Finland.

The **European Union** (EU28) includes Belgium, Bulgaria, the Czech Republic, Denmark, Germany, Estonia, Ireland, Greece, Spain, France, Croatia, Italy, Cyprus, Latvia, Lithuania, Luxembourg, Hungary, Malta, the Netherlands, Austria, Poland, Portugal, Romania, Slovenia, Slovakia, Finland, Sweden and the United Kingdom.

Methods and definitions

The **index of the volume of retail trade** measures the evolution of the turnover in retail trade, adjusted for price changes (deflated), i.e. the evolution of the total amount of goods sold, based on data adjusted for calendar and seasonal effects.

Seasonally adjusted euro area and EU series are calculated by aggregating the seasonally adjusted national data. Eurostat carries out the seasonal adjustment of the data for those countries that do not adjust their data for seasonal effects.

Missing observations from Member States for recent months are estimated for the calculation of the euro area and the EU aggregates.

Revisions and timetable

Data of previous months have been revised compared to those issued in the News Release [40/2019](#) of 5 March 2019. The monthly percentage changes for January 2019 have been revised from +1.3% to +0.9% in the euro area and from +1.1% to +1.0% in the EU28. The annual percentage changes remained at +2.2% in the euro area and was revised from +2.5% to +2.6% in the EU28.
