

# Statistical aspects of the oil economy in 2002

### Structure of supply

Crude oil production in the European Union as a whole rose by 1.0% in 2002 to a total of 148.5 million tonnes, but United Kingdom production fell by 1.3% to 116.1 million tonnes (117.7 in 2001). Denmark, the European Union's second largest producer, saw its output rise by 6.3% to 18.2 million tonnes. Crude oil production in the euro zone was up by 16.2%.

**Extra-EU imports of crude oil** fell by 1.3% to a total of 493.4 million tonnes.

As in the past, the European Union's main suppliers of crude oil were the countries of the Near and Middle East, although their share of EU imports fell yet again, from 27.5% in 2001 to 24.6% in 2002. Imports from Africa also saw their share slide from 22.5% in 2001 to 20.5% in 2002. Imports from Eastern Europe were up from 110.7 million tonnes in 2001 (22.2%) to 135.8 million tonnes in 2002 (27.5%). Imports from Norway accounted for only 19.9% (98.4 million tonnes) compared with 21.4% in 2001 (107.0 million tonnes).

**Imports of petroleum products** were slightly down (-0.1%) from their 2001 level, at a total of 219.4 million tonnes.



## Net oil imports

Net oil imports increased in Ireland (+11.3%), Austria (+6.1%), Greece (+5.1%), Luxembourg (+4.3%) and Spain (+2.2) and decreased in Germany (-5.9%), Sweden (-5.9%), Finland (-4.6%), the Netherlands (-3.9%), Belgium (-1.8%), France (-1.6%), Italy (-1.3%) and Portugal (-0.6%). The United Kingdom and Denmark remained net exporters of oil in 2002, both presenting a growing tendency - the UK up by 5.0% and Denmark up by 47.5%.

## Refining

Refinery input in the European Union and in the euro zone fell by 0.4%. At Member State level, figures were up in Belgium (+15.2%), Finland (+11.4%), the United Kingdom (+1.5%), Italy (+0.4%) and Spain (+0.2%), and down in Sweden (-8.2%), France (-7.1%), Ireland (-7.0%), the Netherlands (-3.4%), Denmark (-3.3%), Portugal (-1.6%), Greece (-0.9%), Austria (-0.3%) and Germany (-0.2%).

## Consumption trends

Total deliveries of petroleum products in both the European Union and the euro zone were 1.3% down on their 2001 levels, the quantities falling from 552.6 to 545.6 million tonnes in the EU and from 459.6 to 453.7 million tonnes in the euro zone.

At Member State level, delivery figures rose in Sweden (+7.3%), Greece (+2.9%), Portugal (+2.7%), Finland (+2.5%), Luxembourg (+2.1%), Spain (+1.5%), Italy (+0.9%), the Netherlands (+0.7%) and Austria (+0.7%), and fell in Belgium (-7.7%), Denmark (-6.0%), Germany (-3.6%), France (-3.3%), the United Kingdom (-2.0%) and Ireland (-0.2%).
