Wind of change in Eurostat's dissemination

Dear Reader,

Eurostat has decided to change its dissemination policy quite considerably, since it will start free dissemination in the fourth quarter of this year. The implications of the new policy are vast for Eurostat. It is not difficult to imagine a tenfold increase in the number of people accessing our data within a short period of time. This has been the experience in those EU Member States which have already changed policy and we expect that this new situation will certainly be a big challenge for Eurostat.

The first steps for free access to our publications and data have already been taken. All Eurostat publications are downloadable free of charge in PDF format from our website.

Furthermore, some 1 000 tables of the most frequently used and demanded short- and long-term indicators are freely available on our website.

Eurostat is currently working on the preparation of its databases for the potential large free dissemination demand in order to improve the userfriendliness, the documentation and the response times.

There is also the important task of spotting potential limits to free dissemination. Legal regulations in different Member States lead to reservations on publishing data at more detailed levels. The limits of free dissemination have to be further explored and concepts developed to deal with the exceptions that will need to be made.

Another important part of free dissemination is the organisation of user support in the different countries. However, the type of assistance must be limited to advice on where to find the requested data or the methodological background information which the user needs. The Data Shops, as we know them today, will disappear. We are sure that private service providers will produce value added services for those users who

Ten new Member States in the statistical focus

Since 1 May 2004, the most extensive enlargement in the history of the European Union has become a fact of life. In recent years, the new member countries have made particular efforts to adopt the acquis communautaire so as to be well prepared for EU membership. These efforts also concern the national statistical systems. The new countries are very much aware that high-quality statistics are crucial for every EU policy. In addition, they are ready to take up the challenge of being active participants in the European statistical system and are able to contribute to its further development.

In the preparation period, a joint effort of statisticians of the 'old' Member States, who contributed their expertise. colleagues from the new member countries, who were willing to share information on their daily work, and Eurostat staff led to major progress. Good use of the assistance provided was made and today high-quality and comparable statistics are available.

The compilation and harmonisation of data and the preparation of publications require constant commitment from and cooperation between a large number

of contributors. Eurostat's production units have made great efforts to increase further the data collection in their respective fields, particularly from the new member countries. Since enlargement took place, Eurostat's policy has been to publish EU-25 aggregates and the relevant data for all 25 Member States. If possible, aggregated data for EU-15 will also be given for a certain period.

Data on new Member States are now integrated into Eurostat's main publications together with the statistics of the other Member States.

Hereafter there are a series of products and database domains, which already give a good picture of the situation of the economic and social life in the new Member States, and comparisons with the 'old' Member States, with aggregates for EU-15 as well as for EU-25.

Some specific publications on the former or current candidate countries which were published leading up to enlargement are also listed in order to present a full overview and an opportunity for comparison.





Information is taken from a diverse range of Eurostat databases, in particular drawing on structural business statistics (SBS), the continuing vocational training survey (CVTS) and the labour costs survey (LCS). The data are generally broken down according to standard SME definitions (in terms of employment size classes for enterprises) and according to the main economic activities of enterprises (in accordance with the NACE classification). In most cases, the information relates to the latest available period, which is normally the reference year 2001.

The pages are updated daily and offer free of charge key aggregate indicators for the EU and the euro zone. The database contains an unrivalled volume of mostly harmonised and, above all, uniformly structured and documented national and European series. Data can be extracted online with the help of a user-friendly browser and customised extractions can be obtained on request. The alert function helps everybody to keep track of what is going on statistically.

Regional statistics — REGIO: REGIO is the database domain relating to the main aspects of economic life in the European Union at regional level. Created in 1975, REGIO is subdivided into 12 statistical domains: demography, migration, economic accounts, unemployment, labour force sample survey, transport and energy statistics, agriculture, education, health, tourism, structural business statistics, and statistics concerning science and technology (including research and development). The regions are classified in line with a specific system called NUTS (nomenclature of territorial units for statistics).







European Business provides a standard set of information for industrial and service activities within the European Union (25 Member States). The 2004 edition includes data for the 10 new Member States, which (subject to data availability) have been fully integrated into the publication, with the inclusion of EU-25 totals wherever these were possible. The aim of the pocketbook is to present updated information on the forest sector in the EU, EFTA and candidate countries. It may be considered to be a compendium of the most relevant Eurostat data sets concerning the forest sector. It is divided into two main parts. The first gives a general description of forest resources, forest ownership, forest condition, employment in the forest sector, the contribution of this sector to national GDP formation and the share of energy produced using woody material. The SATIE domain is intended to satisfy the needs of the users of cyclical macroeconomic data with reference to foreign and intra-Community trade of goods. It contains monthly data which go back to January 1989 and includes estimates carried out by Eurostat for the most recent months.

The domain presents simultaneously: gross values and foreign trade indices as well as the corresponding seasonally adjusted data, by stressing the temporal consistency between these data. For example, the relation volume index x unit value index = value index is ensured for the seasonally adjusted raw data. Similarly, the seasonally adjusted data of the euro-zone area or EU are equal to the amount of the seasonally adjusted data of each Member State.

Macro series for candidate countries and EFTA countries (trade values and growth rates) — ET_EFCC: The ET_EFCC domain contains external trade statistics from candidate countries (from 1999) and EFTA countries (from 1995). The domain contains, for each flow (import, export), monthly and yearly data and growth rates, with a product breakdown according to SITC one-digit classification, and a geographical split between trade with EU countries and trade with third countries.

The trade statistics from candidate countries and EFTA countries are produced by national administrations according to national concepts. Some concepts may differ from EU definitions, which are applied in EU trade statistics as published by Eurostat.
