## A Survey on Capacity Needs for the Conservation and Sustainable Use of Biodiversity in Areas Beyond National Jurisdiction in the Abidjan Convention Area

Areas Beyond National Jurisdiction (ABNJ) are those parts of the oceans which do not fall within the jurisdiction of any individual country (i.e. outside of the Exclusive Economic Zone which countries are entitled to claim under international law). ABNJ comprise 64% of the oceans and include both the water column (the High Seas) and the seabed, ocean floor and subsoil thereof (The Area). They play a key role in the biogeochemical cycles that regulate oxygen and carbon dioxide in our atmosphere and hence, global climate. Moreover, although much of the ABNJ remains unexplored, it is believed to contain vast energy and mineral resources as well as significant biological/genetic resources (UNGA, 2005).

The IKI STRONG High Seas Project, coordinated by Institute for Advanced Sustainability Studies (IASS) and implemented in collaboration with various partners, aims to strengthen regional ocean governance for the conservation and sustainable use of marine biodiversity in areas beyond national jurisdiction (ABNJ /BBNJ) and is focused on two regions: the Southeast Pacific and Southeast Atlantic regions (i.e. Abidjan Convention Area)

The capacity development component of the IKI STRONG High Seas Project in the Abidjan Convention Area is being led by the International Oceans Institute (IOI-SA). The first step in this component is to undertake an assessment of the relevant capacity development needs of the stakeholders in the region. The outcomes of this survey will then guide the development and delivery of subsequent awareness-raising and capacity development activities under the auspices of the project.
