

QUESTIONNAIRE ON SANCTIONING SYSTEM IN MEMBER STATES

Specific Privacy Statement

1. OBJECTIVE

The objective of this questionnaire is to receive information on the sanctioning system related to the fishery and aquaculture policy in the Member States. This processing shall be conducted under the responsibility of **the Head of Unit Legal Matters, Directorate-General MARE acting as the Controller**. As this service may involve collecting and further processing personal data, Regulation (EC) 45/2001 of the European Parliament and of the Council of 18 December 2000 on the protection of individuals with regard to the processing of personal data by the Community institutions and bodies and on the free movement of such data is applicable.

2. WHAT PERSONAL INFORMATION DO WE COLLECT AND THROUGH WHICH TECHNICAL MEANS?

Identification Data

The personal data collected and further processed in the questionnaire are data necessary in order to give the Commission an overview of how the sanctioning system in the fisheries control policy is implemented in the Member States. The personal data concerned is the vessel identification number – the Community Fleet Register Number by means of which it is possible to identify the name and address of the vessel owner and agent.

The processing of personal data linked to this questionnaire is a necessary part of the Commission's work, as mandated by the Treaties, and more specifically in Article 5 of TEU, Article 13 TEU and Articles 244-250 TFEU, and in accordance with Article 1 and Article 11 of TEU. In addition, in line with Article 102 (1) of the Council Regulation (EC) No 1224/2009 establishing a Community control system for ensuring compliance with the rules of the common fisheries policy (the Control Regulation), the Commission may request any relevant information on the implementation of this Regulation.

Technical information

Your reply and personal data will be collected through e-mail. The e-mail system of the European Commission abides by the Commission's security decisions and provisions established by the Directorate of Security.

3. WHO HAS ACCESS TO YOUR INFORMATION AND TO WHOM IS IT DISCLOSED?

The access to all personal data as well as all information collected in the context of this questionnaire is only granted through UserId/Password to a defined population of users, without prejudice to a possible transmission to the bodies in charge of a monitoring or inspection task in accordance with EU legislation. These users are a team of staff members organising the questionnaire inside **DG MARE**.

No personal data is transmitted to parties other than the recipients, and the legal framework mentioned above always applies.

4. THE EUROPEAN COMMISSION WILL NOT SHARE PERSONAL DATA WITH THIRD PARTIES FOR DIRECT MARKETING PURPOSES. HOW DO WE PROTECT AND SAFEGUARD YOUR INFORMATION?

Your replies, together with your chosen language used for drafting the reply, are recorded in a secured and protected database hosted by the Data Centre of the European Commission, the operations of which abide by the Commission's security decisions and provisions established by the Directorate of Security for this kind of servers and services. The database is not accessible from outside the Commission. Inside the Commission the database can be accessed using a UserId/Password.
