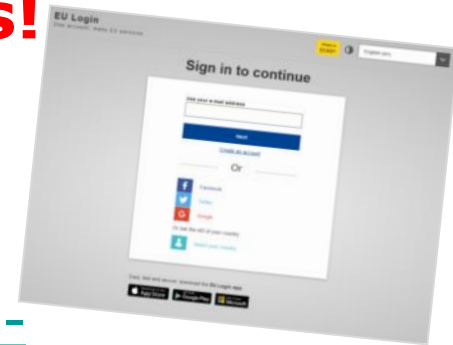

### EU Platform Sub-groups



#### Animal Transport

The sub-group on animal transport both promotes the exchange of experiences and facilitates the cooperation in the area of animal transport, with the purpose of supporting the Platform's work.

The sub-group is composed of 20 members and helps the Platform in gathering information and expertise on how:



#### Welfare of pigs

The subgroup on pigs is a restricted access network that aims to support the Platform's work on pig welfare. This space allows stakeholders to share information, experiences and best practices in order to build voluntary commitments to improve the welfare of pigs.

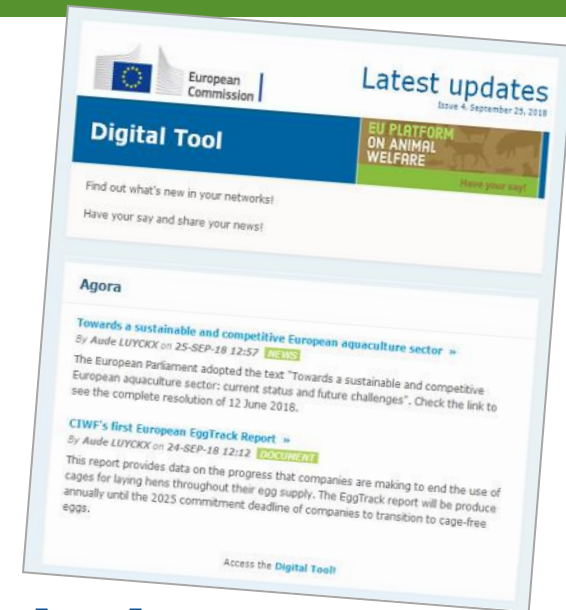

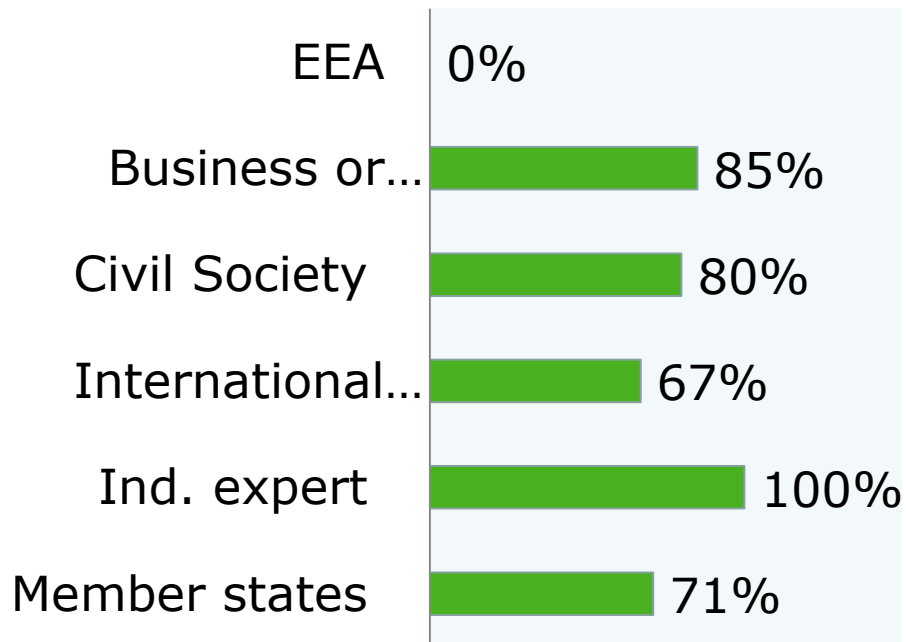
