

**Analysis of major deficiencies detected during the non-discriminatory inspections and action plan to address them
as provided for in Article 27(2) of Regulation (EC) No 1/2005**

1. ANALYSIS OF THE MAJOR DEFICIENCIES DETECTED DURING THE NON-DISCRIMINATORY INSPECTIONS

For the purpose of this annual report, the following have been considered to be major deficiencies:

For the purpose of this annual report, the following have been considered to be major deficiencies:

By comparing non-discriminatory inspection data carried out in accordance with Council Regulation (EC) No. 1/2005, which were carried out during 2016 compared to 2015, the number of non-discriminatory inspections increased by 74.07%, and the total number of identified deficiencies was reduced by -30.68%.

By analyzing data on non-discriminatory inspections carried out in accordance with Council Regulation (EC) No. 1/2005 that were implemented during 2016 in comparison to 2015, the number of non-compliance related to the log of the times referred to in Article 5 and Annex II was established on the certificates of qualification for drivers and road vehicle accompanying vehicles referred to Article 17. Regulation (EC) 1/2005 and the certificate of approval of means of transport by road referred to Article 18. of Regulation (EC) No. 1/2005. For 17.39%.

The above mentioned deficiencies have been identified as the largest number of non-conformities established by non-discriminatory inspections.

Regarding above mentioned we have to adjust better our risk assesment analysis accordance with the situation on the field.

2. ACTION PLAN TO ADDRESS THE DEFICIENCIES DESCRIBED UNDER POINT 1.

Given that despite the increased number of non-discriminatory inspections carried out in 2016 compared to 2015 by 74.07% in relation to the above deficiencies, the Directorate of Veterinary and Food Safety identified the activities to be undertaken:

-Increase the frequency of non-discriminatory inspections of carriers who did not comply with the provisions of Regulation (EC) 1/2005 in respect of the non-conformities relating to the log of the journeys referred to Article 5. and Annex II, on the attestation certificates for drivers and road vehicle accompanying vehicles referred to Article 17. of Regulation (EC) 1/2005 and certificate of approval of means of transport by road with referred to Article 18 of Regulation (EC) No. 1/2005.
