

Technical specifications for harmonised format for the listing of establishments in accordance with Annex IV to Regulation (EC) No 999/2001 (TSE Regulation)

Endorsed at the meeting of the Standing Committee for Plants, Animals and Food on 29 March 2017

Some Member States and operators expressed the need to have easier access to the list of establishments published by MS in accordance with Section A of Chapter V of Annex IV to Regulation (EC) No 999/2001¹, in order

- for the competent authorities to control that raw materials used only come from establishments registered/authorised under feed ban rules
- for operators to have confidence that their providers have properly been authorised/registered.

The Commission will create a master page on the DG SANTE public website with links to this information at national level managed by the Member States.

Member States should provide and keep this information up to date in one of the following two ways:

- Option 1: either the Member State provides a web-link to the national list providing this information in the format provided for in Annex I, or
- Option 2: the Member State adds the information concerning feed ban registrations/authorisation to the existing lists of food, ABP and feed establishments, applying the technical specifications provided for in Annex II.

Member States are strongly encouraged to provide direct links to the lists.

DG SANTE would like to launch its master page on 1 December 2017. Member States should by 1 November 2017:

- Provide the web-link to the national list drawn up based on the format provide for in Annex I if option 1 has been chosen, or

- Inform the Commission that it amended in accordance with the technical specifications provided for in Annex II the existing lists of food/ABP/feed establishments if option 2 has been chosen.

http://ec.europa.eu/food/safety/biosafety/food_hygiene/eu_food_establishments_en shall be supplemented with a column, headed "TSE Feed ban registrations/authorisations" which might

0) remain empty (no authorisations for sourcing);

or

1) include "BLD", meaning slaughterhouses registered as not slaughtering ruminants in accordance with the first paragraph of point (a) of Section C of Chapter IV, as well as authorised slaughterhouses from which non-ruminant blood produced in accordance with the second, third and fourth paragraphs of point (a) of Section C of Chapter IV can be sourced;

and/or

2) include "ABP" meaning slaughterhouses, cutting plants and other establishments registered as, respectively, not slaughtering ruminants, boning or cutting up ruminant meat, and not handling ruminant products, from which animal by-products intended to be used for the production of processed animal protein derived from non-ruminants in accordance with the first paragraph of point (a) of Section D of Chapter IV can be sourced, as well as authorised slaughterhouses, cutting plants and other establishments, from which animal by-products intended to be used for the production of processed animal protein derived from non-ruminants in accordance with the second, third and fourth paragraphs of point (a) of Section D of Chapter IV can be sourced.

Animal by-product (ABP) establishments

The lists of ABP establishments available at: http://ec.europa.eu/food/safety/animal-by-products/approved-establishments_en shall be supplemented with a column, headed "TSE Feed ban registration/authorisations" which might

0) remain empty (no authorisations for production);

or

1) include "BP", meaning processing plants registered as processing exclusively non-ruminant blood in accordance with the first paragraph of point (c) of Section C of Chapter IV, as well as authorised processing plants producing blood products in accordance with the second, third and fourth paragraph of point (c) of Section C of Chapter IV;

and/or

2) include "PAP", meaning processing plants registered as not processing ruminant animal by-products in accordance with the first paragraph of point (c) of Section D of Chapter IV, as well as authorised processing plants producing processed animal protein derived from non-ruminants which operate in accordance with the second, third and fourth paragraphs of point (c) of Section D of Chapter IV.

Feed establishments

The lists of feed establishments available at: http://ec.europa.eu/food/safety/animal-feed/feed-hygiene/approved-establishments_en shall be supplemented with a column, headed "TSE Feed ban authorisations" which might:

0) remain empty (no authorisations for use of products of animal origin mentioned below);

or

1) include "FM", meaning authorised compound feed establishments producing, in accordance with Section B of Chapter III, compound feed containing fishmeal or producing, in accordance with point (d) of Section E of Chapter IV, milk replacers containing fishmeal intended for unweaned farmed animals of the ruminant species;

and/or

2) include "DCP/TCP", meaning authorised compound feed establishments producing, in accordance with Section B of Chapter III, compound feed containing dicalcium and tricalcium phosphate of animal origin;

and/or

3) include "BP", meaning authorised compound feed establishments producing, in accordance with Section B of Chapter III, compound feed containing blood products derived from non-ruminants;

and/or

4) include "PAP", meaning authorised compound feed establishments producing, in accordance with point (d) of Section D of Chapter IV, compound feed containing processed animal protein derived from non-ruminants; as well as authorised compound feed establishments producing, in accordance with point 3(b)(ii) of Section E of Chapter V, exclusively compound feed for export from the Union or compound feed for export from the Union and compound feed for aquaculture animals to be placed on the market;

and/or

5) include "INS", meaning authorised compound feed establishments producing, in accordance with point (b) of Section F of Chapter IV, compound feed containing processed animal protein derived from farmed insects;

Where applicable and when lists of registered feed establishments are not published, the lists of approved feed establishments shall be supplemented with lists of:

- Registered compound feed establishments, authorised to use one of the products in accordance with points 1) to 5);
- Storage plants authorised in accordance with point 3 of Section A of Chapter III or in accordance with the third paragraph of point 3(d) of Section E of Chapter V;

containing the following information:

- Registration number
- Name
- Address
- TSE Feed ban authorisations, using the same product codes as above.
