On Amendments to Some Decisions of the Customs Union Commission

According to Article 3 of the Agreement on the Eurasian Economic Commission dated November 18, 2011 and Article 7 of the Agreement of the Customs Union on Veterinary and Health Measures dated December 11, 2009, the Collegium of the Eurasian Economic Commission **has decided as follows:**

1. Amend the Common Veterinary (Veterinary and Health) Requirements in relation to Goods Subject to Veterinary Control (Inspection) as approved by Decision No. 317 of the Commission of the Customs Union dated June 18, 2010 as per the following Appendix.
2. Appendix to the Common Veterinary (Veterinary and Health) Requirements in relation to Goods Subject to Veterinary Control (Inspection) as approved by Decision No. 830 of the Commission of the Customs Union dated October 18, 2011 shall be repealed.
3. This decision becomes effective upon expiry of 30 calendar days from the date of its official publication.

AMMENDMENTS

made to the Common Veterinary (Veterinary and Health) Requirements in relation to Goods Subject to Veterinary Control (Inspection)

1. Part 1 of the Chapter "General Provisions" shall be ammended as follows:

"Regarding the products subject to surveillance, imported to the Customs Territory of the Customs Union, until the Republic of Kazakhstan accedes the World Trade Organization, the regulatory measures shall apply, which are stipulated by Chapter 1 of the List according to Appendix 1, and as of the moment of accession of the Republic of Kazakhstan to the World Trade Organization - the measures stipulated by Chapter II of the said List."

2. In Part 5 of Chapter 15, the words "Appendices 1 and 2" shall be replaced with the words "Appendices 2 and 3."

3. Appendix 1 shall be added as follows:
