COMMISSION DECISION

of

amending Commission Decision on the awarding of grants for proposals for 2009 under the second Health Programme (2008-2013)

THE EUROPEAN COMMISSION,

Having regard to the Treaty on European Union and to the Treaty on the Functioning of the European Union,

Having regard to Decision No 1350/2007/EC of the European Parliament and of the Council of 23 October 2007 establishing a second programme of Community action in the field of health (2008-2013)¹, and in particular Article 8(2) thereof,

Having regard to Commission Decision of 2 September 2008 SEC(2008) 2395 conferring delegated powers to implement the second programme of Community action in the field of health (2008-2013) to the Director-General of the Directorate-General for Health and Consumers²,

Having regard to the Decision of the Director-General of the Directorate-General for Health and Consumers of 9 September 2008 sub-delegating the exercise of delegated powers concerning decisions on the award of grants in the framework of the second programme of Community action in the field of health (2008-2013) to the Director of Directorate SANCO C "Public health and risk assessment".

Whereas:

- (1) The work plan for 2009 for the implementation of the second programme of Community action in the field of health (2008-2013) was adopted by the Commission on 27 February 2009 (Decision 2009/158/EC)³.
- (2) Commission Decision on the awarding of grants for proposals for 2009 under the second Health Programme (2008-2013) was adopted on 23 September 2009.
- (3) Three reserve lists for projects, conferences and operating grants which could receive Community co-financing within the limits of any available appropriations were

established and set out in Annex V to the awarding decision, the order in which they are listed constituting the order of priority for each list.

- (4) Four conferences constitute the reserve list of proposals for conferences in Annex V to the award Decision whereas five conferences met the threshold for inclusion in the reserve list.
- (5) Commission Decision on the awarding of grants for proposals for 2009 under the second Health Programme (2008 – 2013) should therefore be amended accordingly.

HAS ADOPTED THIS DECISION:

Sole Article

Annex V to Commission Decision on the awarding of grants for proposals for 2009 under the second Health Programme (2008 – 2013) is amended as follows:

A conference entitled "Improving the accessibility of long term mental health care for vulnerable groups in society - SAVECARE", reference number 101973, is added to the "List of proposals in reserve for the award of a financial contribution to specific actions in the form of Conferences" in Annex V to the awarding Decision with the recommended funding of EUR 83 500.

This will increase the total recommended funding for specific actions in the form of conferences on the reserve list from EUR 263 500 to EUR 347 000.
