**establishing the multiannual evaluation programme for 2014 - 2019 in accordance with Article 5 of the Council Regulation (EU) No 1053/2013 of 7 October 2013 establishing an evaluation and monitoring mechanism to verify the application of the Schengen acquis**

## COMMISSION IMPLEMENTING DECISION

of 18.6.2014

**establishing the multiannual evaluation programme for 2014 - 2019 in accordance with Article 5 of the Council Regulation (EU) No 1053/2013 of 7 October 2013 establishing an evaluation and monitoring mechanism to verify the application of the Schengen acquis**

THE EUROPEAN COMMISSION,

Having regard to the Treaty on the Functioning of the European Union,

Having regard to Council Regulation (EU) No 1053/2013 of 7 October 2013 establishing an evaluation and monitoring mechanism to verify the application of the Schengen *acquis* and repealing the Decision of the Executive Committee of 16 September 1998 setting up a Standing Committee on the evaluation and implementation of Schengen<sup>1</sup>, and in particular Article 5(1) thereof,

Whereas:

1. The Commission should establish the multiannual evaluation programme on the basis of which each Member State will be evaluated during the period 2014-2019.
2. The multiannual evaluation programme may be adapted, where necessary, at a later stage.
3. Given that Regulation (EU) No 1053/2013 builds upon the Schengen *acquis*, in accordance with Article 4 of Protocol No 22 on the position of Denmark, annexed to the Treaty on European Union and to the Treaty on the Functioning of the European Union, Denmark notified the implementation of Regulation (EU) No 1053/2013 in its national law. It is therefore bound under international law to implement this Decision.
4. The United Kingdom is taking part in this Decision, in accordance with Article 5(1) of Protocol No 19 on the Schengen *acquis* integrated into the framework of the European Union, annexed to the Treaty on European Union and to the Treaty on the Functioning of the European Union, and Article 8(2) of Council Decision 2000/365/EC<sup>2</sup>.
5. Ireland is taking part in this Decision, in accordance with Article 5(1) of Protocol No 19 on the Schengen *acquis* integrated into the framework of the European Union, annexed to the Treaty on European Union and to the Treaty on the Functioning of the European Union, and Article 6(2) of Council Decision 2002/192/EC<sup>3</sup>.
6. As regards Iceland and Norway, this Decision constitutes a development of the provisions of the Schengen *acquis* within the meaning of the Agreement concluded by the Council of the European Union and the Republic of Iceland and the Kingdom

of Norway concerning the latter's association with the implementation, application and development of the Schengen *acquis*<sup>4</sup> which fall within the area referred to in Article 1 of Council Decision 1999/437/EC<sup>5</sup>.

7. As regards Switzerland, this Decision constitutes a development of provisions of the Schengen *acquis* within the meaning of the Agreement between the European Union, the European Community and the Swiss Confederation on the Swiss Confederation's association with the implementation, application and development of the Schengen *acquis*<sup>6</sup> which fall within the area referred to in Article 1 of Decision 1999/437/EC read in conjunction with Article 3 of Council Decision 2008/146/EC<sup>7</sup>.
8. As regards Liechtenstein, this Decision constitutes a development of provisions of the Schengen *acquis* within the meaning of the Protocol between the European Union, the European Community, the Swiss Confederation and the Principality of Liechtenstein on the accession of the Principality of Liechtenstein to the Agreement between the European Union, the European Community and the Swiss Confederation on the Swiss Confederation's association with the implementation, application and development of the Schengen *acquis*<sup>8</sup> which fall within the area referred to in Article 1 of Decision 1999/437/EC read in conjunction with Article 3 of Council Decision 2011/350/EU<sup>9</sup>.
9. The measures provided for in this Decision are in accordance with the opinion of the Schengen Committee,

HAS ADOPTED THIS DECISION:

#### *Article 1*

This Decision establishes the multiannual evaluation programme for 2014-2019, as set out in the Annex.

#### *Article 2*

The starting date of the multiannual evaluation programme 2014 – 2019 shall be 27 November 2014 and the end date shall be 31 December 2019.
