RAN Manual: Responses to returnees

The manual – Responses to returning foreign terrorist fighters and their families – is now available online!

Concerns within the EU about compatriots who travelled to Daesh-held territories and other terrorist-controlled areas and are now returning have been around for some time. It is vital that local practitioners have all the necessary guidance and support to handle these returns in a safe and appropriate manner. The diverse nature of those within this 'returnee' group complicates the

development of a coherent response: some might be violent extremists with combat experience, others might be disillusioned teens who had been recruited but are now fleeing the terror themselves. Among those returning are children, some born abroad.

The conference 'Responses to returning terrorist fighters and their families'

brought together over 150 practitioners, policy-makers and academics in Brussels on 19 June.



The RAN CoE presented Sir Julian King, EU Commissioner for the Security Union, with a draft version of the manual on how to respond to returnees and their families. The manual includes a list of practitioner recommendations for EU Member States, as well as background information on foreign terrorist fighter returnees, and individual chapters on:



- Investigation and risk assessment;
- Multi-agency agreement on intervention;
- The prosecution route;
- The non-prosecution route / resocialisation;
- Child returnees:
- Cross-cutting issues (gender differentiation, communication, local communication).

Concrete examples of practices being used around Europe, as well as individual case studies, also contribute to the guidance for practitioners.



The final version of the manual, taking into account feedback provided on the conference version, is now available online in English, French, and German.

Podcasts featuring practitioners describing the challenges they face in dealing with returnees are available in French and English. From a police perspective to that of a prison governor, from local authorities to policy-makers - some of those grappling with the challenges provide an insight into what works for them...and where some of the problems lie.
