

## **Global Alliance against Child Sexual Abuse Online**

### **Croatia**

**Policy target No. 1: Enhancing efforts to identify victims and ensuring that they receive the necessary assistance, support and protection**

<b>Operational Goal:</b>	Increase the number of identified victims in the International Child Sexual Exploitation images database (ICSE database) managed by INTERPOL by at least 10% yearly
<b>Actions ALREADY UNDERTAKEN</b>	
<b><i>Description of the actions <u>already undertaken</u></i></b>	<p>Through the Project: "IPA 2009 Capacity Building in the Field of Fight against Sexual Exploitation and Sexual Abuse of Children, and on Police Assistance to Vulnerable Crime Victims" we developed "Standard Operating Procedures on handling in cases of investigations on sexual exploitation and sexual abuse of children, including SOP for investigation distribution and handling IIOC on Internet.</p> <p>Also thru project mentioned above, and some TAIEX workshops, we trained a significant number of police officer and level up their expertise and knowledge in investigation of this type of crime.</p> <p>Croatian police officer also participates in Interpol specialist group on "Grove workspace - network" and in that way contributes to identification of victims.</p>
<b>Actions that WILL BE UNDERTAKEN</b>	
<b><i>Description of the actions that <u>will be undertaken and timeframe</u></i></b>	As soon as possible we are planning to connect on Interpol ICSE date base.

**Policy target No. 2: Enhancing efforts to investigate cases of child sexual abuse online and to identify and prosecute offenders**

<b>Operational Goal:</b>	Establish the necessary framework for the criminalization of child sexual abuse online and the effective prosecution of offenders, with the objective of enhancing efforts to investigate and prosecute offenders
<b>Operational Goal:</b>	Improve the joint efforts of law enforcement authorities across Global Alliance countries to investigate and prosecute child sexual abuse online
<b>Actions ALREADY UNDERTAKEN</b>	
<b><i>Description of the actions <u>already undertaken</u></i></b>	<p>As mention before thru the Project: "IPA 2009 Capacity Building in the Field of Fight against Sexual Exploitation and Sexual Abuse of Children, and on Police Assistance to Vulnerable Crime Victims" and some TAIEX workshops, we developed SOP for handling and investigation of distribution IIOC on Internet, and we trained a significant number of police officer and level up their expertise and knowledge in investigation of this type of crime.</p> <p>Also in new Criminal Code in accordance with the Convention on Cybercrime we criminalize all forms of online child sexual abuse.</p>
<b>Actions that WILL BE UNDERTAKEN</b>	
<b><i>Description of the actions that <u>will be undertaken and timeframe</u></i></b>	<p>With the help of TAIEX soon we will train 15 police officer for using of CPS - Child Protection Software, which will help us in online investigation of distribution of IIOC.</p> <p>Also soon we will train 20 police officer for using categorization software (NetClean Analyze DI).</p> <p>Also soon with the help of the TAIEX we plan to train 15 police officer on how to conduct covert online inquires.</p>

**Policy target No. 3: Enhancing efforts to increase public awareness of the risks posed by children's activities online, including grooming and self-production of images that results in the production of new child pornography that may be distributed online**

<b>Operational Goal:</b>	Develop, improve, or support appropriate public awareness campaigns or other measures which educate parents, children, and others responsible for children regarding the risks that children's online conduct poses and the steps they can take to minimize those risks
<b>Operational Goal:</b>	Share best practices among Global Alliance countries for effective strategies to inform the public about the risks posed by online, self-exploitative conduct in order to reduce the production of new child pornography
<b>Actions ALREADY UNDERTAKEN</b>	
<b><i>Description of the actions already undertaken</i></b>	<p>As mention before thru the Project: "IPA 2009 Capacity Building in the Field of Fight against Sexual Exploitation and Sexual Abuse of Children, and on Police Assistance to Vulnerable Crime Victims" we conducted awareness campaign focused on victims and those who are in risk of becoming victims of sexual exploitation and sexual abuse of children. Thru this campaign were made fliers, brochures and leaflets.</p> <p>Also we contribute in opening of new prevention web site <a href="http://www.sigurnijiinternet.hr">www.sigurnijiinternet.hr</a> , which is web page used for raising public awareness, and where parents, children and other Internet user can find useful advice about safer use of internet and how to protect children.</p> <p>Often our police officers are guests on TV shows, conferences etc. about this topics.</p>
<b>Actions that WILL BE UNDERTAKEN</b>	
<b><i>Description of the actions that will be undertaken and timeframe</i></b>	<p>We will continue through the media to raise awareness about this crime and abuse of children on the Internet.</p> <p>At the mentioned web page <a href="http://www.sigurnijiinternet.hr">www.sigurnijiinternet.hr</a> soon we will have "Red Button" application which will help in reporting crimes against children. Also, plan is that "Red Button" application will be available on as many as possible web pages.</p>

**Policy target No. 4: Reducing as much as possible the availability of child pornography online and reducing as much as possible the re-victimization of children whose sexual abuse is depicted**

<b>Operational Goal:</b>	Encourage participation by the private sector in identifying and removing known child pornography material located in the relevant State, including increasing as much as possible the volume of system data examined for child pornography images.
<b>Operational Goal:</b>	Increase the speed of notice and takedown procedures as much as possible without jeopardizing criminal investigation

<b><i>Description of the actions <u>already undertaken</u></i></b>	
<b>Actions that WILL BE UNDERTAKEN</b>	
<b><i>Description of the actions that <u>will be undertaken and timeframe</u></i></b>	As soon as possible we will try to organize a conference or meeting with ISPs and present them on the Web. INTERPOL's "Worst of"-list". Plan is to convince ISPs to participate in blocking access to child abuse material on the Internet.
