#### THE EUROPEAN COMMISSION.

Having regard to the Treaty on the Functioning of the European Union,

Having regard to Regulation (EU) No 1316/2013 of the European Parliament and of the Council of 11 December 2013 establishing the Connecting Europe Facility, amending Regulation (EU) No 913/2010 and repealing Regulations (EC) No 680/207 and (EC) No 67/2010 (hereafter the 'Connecting Europe Facility Regulation')<sup>1</sup>,

Having regard to Regulation (EU) No 283/2014 of the European Parliament and of the Council of 11 March 2014 on guidelines for trans-European networks in the area of telecommunications infrastructure and repealing Decision No 1336/97/EC (hereafter the 'Connecting Europe Facility – Telecommunication Regulation')<sup>2</sup>,

Having regard to Regulation (EU, Euratom) 2018/1046 of the European Parliament and of the Council of 18 July 2018 on the financial rules applicable to the general budget of the Union, amending Regulations (EU) No 1296/2013, (EU) No 1301/2013, (EU) No 1303/2013, (EU) No 1304/2013, (EU) No 1309/2013, (EU) No 1316/2013, (EU) No 223/2014, (EU) No 283/2014, and Decision No 541/2014/EU and repealing Regulation (EU, Euratom) No 966/2012<sup>3</sup> and in particular Article 200 thereof.

#### Whereas:

- (1) In accordance with the 2018 CEF Telecom Work Programme<sup>4</sup>, the Innovation and Network Executive Agency (hereinafter referred to as "the Agency") published the call for proposals "CEF-TC-2018-2" on 3 May 2018 with the deadline of 18 September 2018.
- (2) The Agency received 35 proposals in response to this call. Of these proposals, 4 failed to satisfy the admissibility and eligibility criteria set out in the work programme.
- (3) The proposals were evaluated and ranked by independent external experts, in accordance with the procedures set out in Article 200 of the Financial Regulation.
- (4) The Agency authorising officer carried out checks on operational and financial capacity.
- (5) Following this evaluation (and having regard to the available budget— within the limit of the maximum variation of up to 20% of the indicative budget set out in the work programme—), the authorising officer drew up a proposal for a funding decision.

- (6) The decision on the amount of financial assistance to be granted to the projects selected requires under Article 18 of Connecting Europe Facility Regulation an adoption in *mode décisionnel*.
- (7) The powers to adopt such decisions have been delegated by Commission Decision C(2015) 4172 of 17 June 2015 to the Director-General of DG Communications Networks, Content & Technology.
- (8) The measures provided for in this Decision are in accordance with the opinion of the Committee set out by Article 25 of Regulation (EU) No 1316/2013.
- (9) As a result, the proposals listed in Annex 1 should be funded.

## HAS DECIDED AS FOLLOWS:

#### Sole Article

The proposals listed in Annex 1 are selected and awarded a grant, for the maximum amounts set out in that Annex.
