"Actions will be eligible to receive a pre-financing of up to 50% of the maximum grant amount awarded that will be made within 30 days after the last party signs the grant agreement. No interim payment will be made."

shall read:

"Actions will be eligible to receive a pre-financing of up to 60% of the maximum grant amount awarded that will be made within 30 days after the last party signs the grant agreement. No interim payment will be made."

(3) On page 20 section 15 "Information for applicants", the following paragraph

"The answers to submitted questions will be published in a FAQ list accessible via the call webpage, to ensure equal treatment of all potential applicants. Questions related to the call should be submitted at the latest by **28 April 2020** to ensure sufficient time for the last update of the FAQs by **12 May 2020**. However, individual technical questions related to TENtec eSubmission module will be treated until the call deadline."

"The answers to submitted questions will be published in a FAQ list accessible via the call webpage, to ensure equal treatment of all potential applicants. Questions related to the call should be submitted at the latest by **4 June 2020** to ensure sufficient time for the last update of the FAQs by **18 June 2020**.
