

## List of Participating Countries in the Union Civil Protection Mechanism (UCPM)

### EFTA countries which are part of the European Economic Area (EEA)

- Iceland participates in the UCPM since 2014.
- Norway participates in the UCPM since 2014.
- Liechtenstein does not participate in the UCPM.

### Acceding countries, candidate countries and potential candidates

- Albania participates in the UCPM (*agreement signed on 18 November 2022 – entry into force on 1 January 2023*)
- Bosnia and Herzegovina participate in the UCPM (*agreement signed on 6 September 2022 – entry into force on 6 September 2022*)
- Moldova participates in the UCPM (*agreement signed on 29 September 2023 – entry into force on 1 January 2024*)
- Montenegro participates in the UCPM (*agreement signed on 29 September 2014 – entry into force on 21 April 2015*)
- North Macedonia participates in the UCPM (*agreement signed on 1 September 2014 – entry into force on 30 June 2015*)
- Serbia participates in the UCPM (*agreement signed on 16 April 2015 – entry into force on 26 May 2015*)
- Turkey participates in the UCPM (*agreement signed on 6 May 2015 – entry into force on 4 April 2016*)
- Ukraine participates in the UCPM (*agreement signed on 20 April 2023 – entry into force on 12 December 2023*)
- Kosovo\* does not participate in the UCPM.
