

DG Interpretation bursaries

Do you want to become a conference interpreter?

→If yes, you may be eligible for a study bursary from the Directorate General for Interpretation.

IF

1. you are a national of an EU Member State or of one of the candidate countries (Albania, The Republic of North Macedonia, Montenegro, Serbia or Turkey),
and
2. you already have a university degree or equivalent qualification, or are in the final year of a course leading to a university degree or equivalent qualification,

AND IF

1.
 - i) you have applied or intend to apply for a **full Master/postgraduate course in conference interpreting** offered for the year **2021-2022** by a recognised university or university-level institution. For courses that last more than one year, *only final year students will be eligible*,
and
 - ii) you need to pay/have paid an **enrolment fee for academic year 2021-2022** (= final year of your Master/Postgraduate course)
→*The enrolment fee can be a tuition fee and/or an administrative fee,*
→*Please note that you are not eligible to apply if your Master/postgraduate course is free of charge,*
2.
 - i) you are **registered** with one of the following **active languages** in your course:
Bulgarian, Croatian, Czech, Danish, Dutch, English, French, German, Greek, Irish, Italian, Maltese, Portuguese, Slovak or Slovene,
OR
 - ii) you are **registered** with one of the following **active languages** in your course, **with a retour into English, French or German**: Estonian, Finnish, Hungarian, Latvian, Lithuanian, Polish, Romanian, Spanish or Swedish,

AND your **passive languages** and/or **retour language** are in line with the preferential profiles as published [here](#)

→If you have any **additional languages** which would bring your combination in line with ‘the preferential profiles’ these may also be taken into account if proof is provided that this language knowledge is of an appropriate level (at least C2 CEFR) and has been tested (diploma or certificate) or confirmed by a qualified person/authority.

THEN you may apply for a study bursary from the Directorate General for Interpretation.

Selection procedure

1. In granting study bursaries, preference will be given to applicants offering [a language combination which is most suited to DG Interpretation's current and foreseeable needs](#). **Selection will be based on the applicant's language combination and on the assessment of the potential of the candidate.**
2. Eligible application files will be considered by the **Bursaries Evaluation Committee**, which will meet around the end of October 2021. The Committee will submit a list of possible beneficiaries to the Authorising Officer for award decision.
→The award decision is final; however, questions can be sent to: scic-bursaries@ec.europa.eu
3. All applicants will be informed of the outcome of the selection before the end of November 2021 and short-listed applicants will receive a bursary offer.
→All communication will be sent by e-mail or through the application platform.
4. The **bursary** will amount to the equivalent of the **enrolment fee** (tuition and/or administrative fees) **for academic year 2021-2022**, with a **ceiling amount of EUR 3 000**, and will consist of **one single payment**.
→If the enrolment fee is not paid in euro, the bursary amount will be calculated following the [currency conversion rate of 30 September 2021](#).

Please note that

1. a DG Interpretation bursary is intended as a contribution towards study expenses, but not necessarily covering all costs. It can be combined with additional funds provided by the university, by the Member State or by other public or private bodies;
2. DG Interpretation bursary holders can only benefit once from this scheme and may not benefit at the same time from other bursaries, allowances, salaries or other revenues paid directly or indirectly by the European Union;
3. EU-accredited interpreters (ACI) are not eligible to receive a bursary;
4. failing to attend the course on a regular basis or abandoning the course may make you liable to repay all or part of the bursary;
5. where the Master/postgraduate course is of more than one-year duration, **only final year students will be eligible**;
6. bursary beneficiaries commit themselves to applying for an inter-institutional accreditation test after completion of their Master/postgraduate, and to sitting it if invited to do so by the EU Institutions.

Deadline for submissions: Tuesday 14 September 2021, at 23h59 at the latest (*Brussels time*)

Complete [here](#) the inter-active application form 2021/2022 (compulsory!)¹ and **upload all the documents listed below:**

1. a copy of your passport or identity card (front and back);
2. a detailed CV, in French, German or English, listing all your qualifications. The use of the [‘europass’ template](#) is compulsory;
3. a short motivation letter (between 250 and 500 words), written in your mother tongue;
4. a scanned copy of the completed [university information form](#)²;
5. the form related to your [bank details](#), duly signed and dated (please read carefully the instructions given in the footnotes on the form);
6. the [legal entity](#) form, duly signed and dated (please read carefully the instructions given in the footnotes on the form), and
7. a copy of your last university degree.

The originals of the bank details form and the legal entity form should be kept by the applicant and sent to DG Interpretation upon request.

Please observe the deadline indicated. No application will be considered after this date.

DG Interpretation reserves the right to ask for complementary evidence related to any element of your application (e.g. copy of your university degree, proof of payment of enrolment fees (tuition and/or administrative fees), etc.), at any time, including after the award decision and until three years starting from payment of the bursary.

¹ Please note that the application form is only available in English and French.

² If the entrance test of your master/postgraduate in conference interpreting takes place after the submission deadline of 14 September 2021, you are not obliged to upload the university information form. Please note however that all other forms need to be filled out and uploaded before the deadline, if not your request will not be taken into account. After the entrance test (and on the condition that you passed it), the university will send the university information form (duly filled out, dated and signed) to SCIC BURSARIES, after which we will upload it into your application file for you.

In order to protect EU financial interests, the Commission may also carry out checks and audits to determine that the beneficiary is complying with the obligations under the Bursary scheme.

The European Anti-Fraud Office (OLAF) has the same rights as the Commission, particularly the right of access to documents, for the purpose of checks and investigations.

Under Council Regulation (Euratom, EC) No 2185/96³ and Regulation (EU, Euratom) No 883/2013⁴ OLAF may also carry out on-the-spot checks and inspections in accordance with the procedures laid down by Union law for the protection of the financial interests of the Union against *fraud* and other *irregularities*. The European Court of Auditors and the European Public Prosecutor's Office established by Council Regulation (EU) 2017/1939 ('the EPPO') have the same rights as the Commission, particularly the right of access, for the purpose of checks, audits and investigations.

The beneficiary must provide any information, including information in electronic format, requested by the Commission or by any other outside body authorised by the Commission. Information and documents provided as part of checks or audits must be treated on a confidential basis.

Additional information on those checks and audits can be found in section 3 of the implementing decision of the bursaries programme.
