## Notified requirements - 1

Applicability	Both establishment and cross-border provision of services
Requirement	An obligation on a service provider to obtain an authorisation from a competent authority, including entry in a register or registration with a professional body or association in our territory, except where provided for in the Services Directive or other instruments in Community law
Justification (Public interest objective)	Public health Public policy

### Notified requirements - 2

Applicability	Both establishment and cross-border provision of services
Requirement	An obligation on the provider to have an establishment in the territory of our Member State
Justification (Public interest objective)	Public policy Public health

## Notified requirements - 3

Applicability	Both establishment and cross-border provision of services
Requirement	A requirement, other than those concerning matters covered by Directive 2005/36/EC or provided for in other Community instruments, which reserves access to the service activity in question to particular providers by virtue of the specific nature of the activity
Justification (Public interest objective)	Public policy Public health
