
About

The EU Pilot project was introduced by the Commission with a number of volunteer Member States in 2008 with the aim of improving the cooperation between Member States and the Commission on issues concerning the **conformity** of national law with EU law or the **correct application of EU law**. As a general rule, EU Pilot is used as a **first step to try to clarify or resolve problems**, so that, if possible, formal infringement proceedings can be avoided. Currently 27 Member States are participating in EU Pilot.

Performance

Member States and the Commission use an online platform, EU Pilot, to clarify the factual and legal background of problems arising in relation to the application of EU law. EU Pilot discussions also allow Member States to **remedy potential EU law infringements by complying voluntarily** with the Commission's position. The project was initiated in 2008 with the participation of 15 Member States; by mid-2012, the entire EU-27 had signed up.






For the average response time of the Member States a benchmark of 70 days has been set.

To give an objective overview of the Member States' performance, the traffic light colours "red", "yellow" and "green" have been attributed according to the following rules:

- Countries with an average response time of 71 to 77 days were rated as "close to benchmark" (yellow).
- Countries with an average response time of 70 days or less were rated as "respecting benchmark" (green).
- Countries with an average response time of 78 days or more were rated as "beyond benchmark" (red).

Achievements

- **Full EU-27 participation** in EU Pilot (Luxembourg and Malta joined in June 2012).
- IT developments to make the **use of EU Pilot** more **user-friendly**, such as the new reinforced passwords procedure and more practical file editing solutions.

Facts and Figures

Between 1 June 2012 and 26 March 2013, the Commission opened almost 1 251 EU Pilot files.

In principle, EU Pilot covers the entire "acquis": Member States and the Commission may discuss any potential problem involving the application of EU law, including the Single Market Legislation. However, EU Pilot is not used in specific areas where similar mechanisms had already been installed before the introduction of EU Pilot.


Following the receipt of Member States' responses, the Commission evaluated 318 EU Pilot files during the above period. Until now, 237 files were closed because the Member State provided a satisfactory response; 1014 files were still pending. This equals to a **75 % average resolution rate for the EU-27**. In the remaining cases (77 files), the

Commission initiated formal infringement procedures by sending a letter of formal notice under Article 258 TFEU.

The three Member States that received the most EU Pilot files during the reference period were Italy (94), Spain (86) and France (81).

24~% of the 1 251 investigations that were launched in EU Pilot since 1 June 2012 related to environmental issues, 12~% to internal market and services, 8~% to taxation and customs union, 15~% to mobility and transport and 8~% to justice, fundamental rights and citizenship. Those policy areas represent altogether 67~% of the total number of EU Pilot files.

- Merging the EU Pilot with the Commission's infringement database
- Launching of an EU Pilot e-Learning tool
- Smooth introduction of EU Pilot at the Croatian authorities
