### **Austria**

# Transposition of law

**Transposition deficit: 1.2%** (*last report: 1.2%*) – Stable result, still above the 1% threshold (with 6 other Member States). In addition, Austria has transposed 17 of the 23 directives (74%) with a transposition date within 6 months before the cut-off date for calculation (1.6.2018 – 30.11.2018). This shows that this Member State could monitor the timely transposition of Single Market-related directives even better. *EU average = 0.7%; Proposed target (in Single Market Act) = 0.5%* 

**Overdue directives: 12** (*last report: 16*) including 3 environmental directives. **Two** directives are more than 2 years overdue: (1) Directive (EU) 2016/882 amending Directive 2007/59/EC as regards language requirements for train drivers, and (2) Directive (EU) 2015/720 regarding the reduction of the consumption of lightweight plastic carrier bags.


**Average delay: 9.4 months** (*last report: 10.8 months*) – Decrease by 1.4 months. Austria added two long overdue directives (due for 2 years or more) to its backlog, but all of its remaining 10 outstanding directives have been due for less than 12 months.

EU average = 8.4 months


**Conformity deficit: 1.1%** (*last report: 0.9%*) – New increase that puts Austria in a group of 8 Member States whose deficit is more than twice the target proposed in the Single Market Act. Austria has now 11 directives presumably incorrectly transposed.

EU average = 0.8%; Proposed target (in Single Market Act) = 0.5%

# **Infringements**

**Pending cases: 27** (6 new cases and 7 cases closed; last report: 28 pending cases) – Slight decrease by 1 case and stable result since May 2012 (between 23 and 29 cases). Austria is now close to the EU average number of Single Market-related cases.

EU average = 25 cases.

**Problematic sectors:** transport (7 cases) and public procurement (5) = 44% of all pending cases.


**Average case duration: 33 months** for the 22 cases not yet sent to the Court (*last report: 30 months*) – Increase by 3 months. Austria is no longer in the top 5 Member States with the shortest average case duration. However, it remains well under the EU average. Since December 2017, Austria managed to resolve 7 cases whose average duration was around 2 years. Only 2 out of its 22 remaining cases have been ongoing for more than 5 years.

EU average = 38.1 months

Compliance with court rulings: 56.7 months for the 3 cases at this stage of the procedure and closed in the last 5 years (*last report: 32.5 months*) – Highest increase (by 24.2 months) among the 25 Member States that complied with judgments of the Court within the last 5 years. This huge increase adds to the increase by 23.1 months registered in December 2017. Austria is now the Member State with the longest time lag for compliance (moving up from 3rd position a year ago). Austria now has 3 cases older than 5 years – all of them with a short compliance duration (8.4 months on average) – which are no longer part of the calculation. On the other hand, Austria managed to resolve a case on education that had been ongoing for more than 11 years, and which weighs heavily in the calculation of the average duration of its moderate number of cases (3).

EU average = 28.2 months

### **EU Pilot**


Austria's average response time currently exceeds the 70-day time limit in EU Pilot by less than a week.

# Internal Market Information System

Performance – Austria continues to perform very well.

- The percentage of requests answered by the agreed deadline improved significantly.
- 4 out of 5 indicators were above the EEA average.
- Austria continues to be one of the most active Member States in sending requests based on the Services Directive: It sent 58% of all requests in this area.

**Your Europe** 

The EU has set up a **single digital gateway** providing access to information, to procedures and to assistance and problem-solving services.

The specific regulation setting up the single digital pathway is Regulation 2018/1724 of 2 October 2018. Article 29 of the Regulation establishes establishes a group to coordinate work on the gateway. The gateway coordination group will meet in three configurations, one devoted to information, meeting twice a year. The other two configurations are dedicated to ICT and e-procedures and assistance services.

The information group will largely continue the work of the Your Europe Editorial Board. This is to ensure that the gateway coordination group's work does not overlap with that of other expert groups or sub-groups.



### Postal services

# Trade in goods and services

Austria's trade integration in the single market for goods and services is above the EU average. In 2017, Austria'strade integration in goods increased slightly, whereas its trade integration in services rose in line with EU average.

# Foreign Direct Investment (FDI)

In 2017, Austria's share of intra-EU FDI inflows increased markedly whereas outflows increased at a lower rate. Its shares of both inward and outward intra-EU FDI stock saw a small increase in 2017.

In 2017, Austria's share of extra-EU FDI outflows increased markedly whereas inflows increased at a lower rate. The share of inward extra-EU FDI stock saw a small increase in 2017, while the share of outward extra-EU FDI stock remained unchanged.
