THE EUROPEAN COMMISSION,

Having regard to Regulation (EU, Euratom) No 966/2012 of the European Parliament and of the Council of 25 October 2012 on the financial rules applicable to the general budget of the Union and repealing Council Regulation (EC, Euratom) No 1605/2002 (hereinafter referred to as the 'Financial Regulation')¹, and in particular Article 133 thereof,

Having regard to Commission Delegated Regulation (EU) No 1268/2012 of 29 October 2012 on the rules of application of Regulation (EU, Euratom) No 966/2012 of the European Parliament and of the Council on the financial rules applicable to the general budget of the Union (hereinafter referred to as the 'Rules of Application')², and in particular Article 204 thereof,

Having regard to Council Decision No 2007/252/EC of 19 April 2007 establishing, for the period 2007-2013, the specific programme "Fundamental Rights and Citizenship"³ as part of the General Programme "Fundamental Rights and Justice", and in particular, Article 4(b) thereof,

Whereas:

- (1) The Commission adopted the financing decision for 2013 of the specific programme "Fundamental Rights and Citizenship" ⁴, which aims to co-fund transnational projects through a call for proposals for action grants under the budget line 33 02 04;
- (2) The call for proposals JUST/2013/FRC/AG was published with a deadline of 12 March 2014;
- (3) An Evaluation Committee was appointed pursuant to Article 204(1) of the Rules of Application in order to evaluate the applications submitted under the above mentioned call for proposals and to identify the proposals which may receive funding;
- (4) The Evaluation Committee established an Evaluation Report which contains all the information required under Article 204(4) of the Rules of Application;
- (5) The Committee established by Article 10 of Regulation No 1381/2013/EU of the European Parliament and of the Council has been consulted according to Article 15 of the same Regulation under the advisory procedure on the proposed award of grants pertaining to the Fundamental Rights and Citizenship programme and has given a favourable opinion;

HAS DECIDED AS FOLLOWS:

Article 1 Selected Proposals

The proposals listed in Annex 1 to this Decision shall be awarded a grant under the "Fundamental Rights and Citizenship" programme– call for proposals JUST/2013/FRC/AG, up to the maximum amount indicated in that Annex. The overall amount of financing provided is **EUR 10. 668. 144,71**;

Article 2 Reserve list

The proposals listed in Annex 2 to this Decision shall be awarded a grant under the "Fundamental Rights and Citizenship" programme – call for proposals JUST/2013/FRC/AG, up to the maximum amount indicated in that Annex, subject to the availability of funds;

Article 3 Non Selected Proposals

The proposals listed in Annex 3 to this Decision are not selected for financing under the "Fundamental Rights and Citizenship" programme– call for proposals JUST/2013/FRC/AG.
