THE EUROPEAN COMMISSION,

Having regard to the Treaty on the Functioning of the European Union,

Having regard to Regulation (EU, Euratom) 2018/1046 of the European Parliament and of the Council of 18 July 2018] on the financial rules applicable to the general budget of the Union, amending Regulations (EU) No 1296/2013, (EU) No 1301/2013, (EU) No 1303/2013, (EU) No 1304/2013, (EU) No 1309/2013, (EU) No 1316/2013, (EU) No 223/2014, (EU) No 283/2014, and Decision No 541/2014/EU and repealing Regulation (EU, Euratom) No 966/2012¹, and in particular Article 110 thereof,

Having regard to Regulation (EU) No 236/2014 of the European Parliament and of the Council of 11 March 2014 laying down common rules and procedures for the implementation of the Union's instruments for financing external action², and in particular Article 2(1) thereof,

Whereas:

- (1) By its Decision C(2019) 8735 of 28.11.2019 the Commission adopted the Annual Action Programme in favour of the Eastern Partnership region for 2019, Part 5 to be financed from the general budget of the European Union including one action.
- (2) It is now necessary to modify the action "European School in Georgia", Annex 1, by increasing the Action budget, extending the implementation duration and introducing a new specific objective.
- (3) These changes also require introducing a set of complementary activities corresponding to the new specific objective, as well as minor reallocation of funds within the same action to integrate the additional funding.
- (4) Therefore, Decision C(2019) 8735 should be amended accordingly.
- (5) This amendment is in accordance with the opinion of the ENI Committee set up by Article 15 of Regulation (EU) No 232/2014.

HAS DECIDED AS FOLLOWS:

Sole Article

Commission Implementing Decision C(8735) of 28/11/2019 (The ENI East Regional Action Programme 2019, Part 5) is amended as follows:

Article 2: Union Contribution is replaced by the following Article:

Article 2
Union contribution

The maximum Union contribution for the implementation of the programme is set at EUR 9 400 000 and shall be financed from the appropriations entered in the following line of the general budget of the Union:

(a) 22.04.02.02: EUR 6 400 000 for 2019

(b) 22.04.02.02: EUR 3 000 000 for 2020

The appropriations provided for in the first paragraph may also cover interest due for late payment.
