#### 2 DESCRIPTION OF THE ACTION PROGRAMME

##### 2.1 SECTORS SELECTED UNDER THIS ACTION PROGRAMME

- Rationale for the selection of the specific sectors under this programme:

Following the adoption of the relevant countrywide sector strategies and as a result of the mid-term review of the Indicative Strategy Paper for Bosnia and Herzegovina 2014-

2020<sup>1</sup>, the Commission proposes the Annual Action Programme for the year 2018 to cover five sectors: Democracy and Governance; Rule of Law and Fundamental Rights; Environment, Climate Action and Energy; Competitiveness, Innovation, Agriculture and Rural Development; and Education, Employment and Social Policies.

The actions in the sector of democracy and governance will continue contributing to improved economic governance in the country, strengthening EU-Bosnia and Herzegovina cooperation and preparation for EU integration and to increase local communities' awareness on EU values and the EU integration process. This will be achieved through the improvement of the quality of the Economic Reform Programme (ERP), building up on the support already provided by the EU through a regional project implemented by the Organisation for Economic Co-operation and Development (OECD); and by strengthening the capacity of young civil servants through an exchange programme among the different administrative levels within Bosnia and Herzegovina. Furthermore, the EU will continue supporting the participation of Bosnia and Herzegovina in EU Programmes, through co-financing the costs of the entry tickets for specific EU programmes. Finally, a specific action will increase general awareness of local communities in Bosnia and Herzegovina on EU values and the EU integration process benefits, through support of small/medium size interventions related to the EU integration requirements and EU policies and the improvement of their learning and living environment.

The proposed actions in the rule of law and fundamental rights sector will strengthen the independence, transparency, efficiency, accountability and ultimately public trust in the justice system of Bosnia and Herzegovina in line with European standards and the EU *acquis*. This will be achieved through the implementation of key recommendations from the Stabilisation and Association Agreement process as well as the promotion of effective prosecution by enhancing cooperation between law enforcement and prosecution services. Support under this programme will also aim at further reduction of war crimes cases backlog. One of the actions will contribute to increased efficiency of police agencies in Bosnia and Herzegovina in faster and more efficient identification of the perpetrators of criminal acts, through improved biometric data processing in the Automated Fingerprint and Palm Print Identification System, thereby supporting international data exchange through the improvement of cross-border cooperation, particularly in combating terrorism and cross-border crime. Additionally, the establishment of an EU Gender Equality Facility will aim at strengthening the effective implementation of domestic and international legal frameworks concerning gender equality and women's rights, as well as supporting the country in aligning to the EU gender equality *acquis* in the pre-accession perspective.

This is the first Annual Action Programme for Bosnia and Herzegovina under the Instrument for Pre-Accession Assistance (IPA II) that includes an action in the sector of environment, climate action and energy. The action in the environment sector will contribute to the overall protection of the environment and Bosnia and Herzegovina's sustainable development. It will support reforms to continue transposition of environmental *acquis* in the area of water management, and the development of water and sanitation infrastructure.

The sector competitiveness, innovation, agriculture and rural development also includes a new sub-sector. The action on agriculture and rural development will increase the competitiveness of the sector by delivering support to value chains and capacity building

to sector stakeholders. At the same time it will support alignment with the EU *acquis* with the aim of increasing exports to the EU by continuing the strengthening of veterinary, phytosanitary, and food safety institutions. The action supporting trade aims at increasing Bosnia and Herzegovina's share in international and regional trade by improving its trade in goods and services in line with international integration requirements. Finally, the action on demining, within the sector of education, employment and social policy will support Bosnia and Herzegovina in fulfilling its commitments as a signatory of the Anti-Personnel Mine Ban Convention and in the implementation of the 2018-2025 Bosnia and Herzegovina Mine Action Strategy.

- Overview of past and on-going EU, other donors' and/or IPA II beneficiary's actions in the relevant sectors:

The EU has been supporting capacity building of the civil service since 2004, including through the IPA 2017 action 'EU support to an efficient and responsible public administration' and the IPA regional 'Young Civil Servants' programme. Bosnia and Herzegovina – as other Western Balkans countries - has received support to the design of its Economic Reform Programmes (ERPs), such as the IPA regional programme implemented by the OECD. While in Bosnia and Herzegovina institutional capacity has to some extent increased following OECD intervention, the need remains for continued support to ERP coordinators and specifically for the preparation and support of reforms in line ministries and other governmental institutions.

The EU has provided substantial support to Bosnia and Herzegovina authorities in the areas of justice, fight against corruption, war crime cases processing and other topics affecting these areas. The present action shall notably build upon the expected results of the phase 1 of the EU4Justice grant project for Bosnia and Herzegovina funded under IPA 2015. Earlier support in the home affairs sector has shown that the success of any intervention is directly proportionate to the extent to which the involved institutions cooperate, share, and exchange information, in particular in the establishment and functioning of databases, which has been duly taken into account in the design of the present Automated Fingerprint and Palm Print Identification System (AFIS/APIS) action. An exceptional assistance measure was approved in December 2017 under the Instrument contributing to Stability and Peace (Programme ref: IcSP 2017/30) under the leadership of the Mine Action Centre in Bosnia and Herzegovina BHMACE and will contribute to the development of an accurate mapping of the suspected mine-contaminated areas in Bosnia and Herzegovina.

On trade previous IPA assistance included institutional capacity development and the strengthening of the legal framework. Nevertheless, despite the progress so far, further technical assistance is needed to boost the Country's long-lasting processes. To do so a lesson learned is to look not only at laws alignment with the *acquis*, but also to ensure that the legislative drafting and policy-making processes ensure proper inter-ministerial coordination, impact assessment of proposed laws and policies as well as external (public) consultation of the relevant stakeholders. Furthermore, successful coordination of assistance provided through national and multi-beneficiary IPA projects is crucial.

Previous assistance on mine action supported countrywide survey and clearance activities, in particular in conflict sensitive areas with returnees and Internal Displaced People (IDP). This assistance improved the living conditions of local communities by making available previously unusable natural and infrastructure resources, supported mine risk awareness activities, including mine signalisation and mine risk education at schools. Socio-economic and psychological assistance projects were tailored to address the needs of mine victims. EU supported the national mine action authorities to successfully introduce the land release concept in Bosnia and Herzegovina a cost

effective method to achieve the objective of a 'mine free Bosnia and Herzegovina' in line with the 2025 the Anti-Personnel Mine Ban Convention deadline.

Bosnia and Herzegovina has benefited from significant EU assistance related to capacity building and supplies in the fields of agriculture, rural development, food safety, veterinary and phytosanitary for which IPA 2007-2013 allocated approximately EUR 27 million. Moreover, technical assistance has been provided to sectors priority areas through Technical Assistance and Information Exchange (TAIEX), Twinnings and Better Training for Safer Food (BTSF) programmes. The sector did not receive the needed support under IPA II yet because of the lack of a country-wide sector strategy. Insufficient knowledge of the public and of interest groups when it comes to the implications, processes and opportunities related to EU accession also contributed to slowing down its development. Due to these challenges only a limited number of donors' programmes are currently ongoing (e.g. Swedish International Development Cooperation Agency (SIDA)/ The United States Agency for International Development (USAID)/Czech Republic) or are planned. A lesson learnt is that policy and legislative developments needs to be evidence-based, costed and subject to internal and external stakeholder consultations at the right time of the legislative and policy-making process to ensure ownership in terms of enforcement of adopted policies and legislation, in the reforms process.

## DESCRIPTION AND IMPLEMENTATION OF THE ACTIONS

### *(1) Description of the Action, objective, expected results and key performance indicators*

Description of the Action: This Action will build on the earlier EU support to the improvement of the Economic Reform Programme (ERP) provided through the regional Organisation for Economic Cooperation and Development (OECD) implemented project, especially regarding capacity building of the institutions of all levels of government in Bosnia and Herzegovina to prepare and implement the ERP.

The overall objective is to strengthen economic fundamentals and growth in Bosnia and Herzegovina in view of economic criteria for EU accession and of the requirements of economic policy coordination in the European Semester.

The specific objective is to improve Economic Reform Programme preparation and implementation.

#### Expected results:

- Capacities of line ministries and other government institutions for preparation and implementation of ERP strengthened and improved,
- Capacities of the institutions of the ERP coordinators strengthened and improved.

#### Key performance indicators:

- Evolution in grade in Economic Reform Programme assessment by the Commission;
- Number of staff trained in prioritization, diagnostics, reform formulation and monitoring of ERP;
- Number of trained civil servants for the software use and in the methodology for collection, dissemination and consolidation of fiscal data and public debt data;
- Number of capacity building activities of the coordinating institutions;
- Number of awareness raising activities.

### *Assumptions:*

- Full commitment and support of the decision-makers of the involved institutions;
- Good cooperation between relevant partners and willingness to adapt to changes where necessary;
- Technical and human resources required for action implementation allocated;
- Institutional settings defined and staff available to benefit from the Technical Assistance.

### *Conditions:*

- All ERP coordinating institutions should (re)confirm their agreement to this action prior to the tender launch.

Failure to comply with the requirements set out above may lead to a recovery of funds under this programme and/or the re-allocation of future funding.

### ***(1) Description of the Action, objective, expected results and key performance indicators***

Description of the Action: One of the components of this action will provide flexible support to the authorities in Bosnia and Herzegovina at various levels to address specific and unforeseeable technical assistance needs identified in the course of the European integration process. Another component foresees an intra-Bosnia and Herzegovina programme and exchange for young civil servants from Bosnia and Herzegovina. Eligible beneficiaries for this Action are line-ministries and government institutions/agencies at various levels of government and staff directly involved in the EU accession process.

The overall objective is to contribute to Bosnia and Herzegovina's overall progress in fulfilling its obligations for European Union accession;

The specific objective is to strengthen the capacity of public administration in Bosnia and Herzegovina at all levels of government, and young civil servants in particular, for accession negotiations, transposition of EU *acquis* and implementation of EU policies.

### Expected results:

- More effective and timely responses to emerged EU integration priorities are given by authorities in Bosnia and Herzegovina at all levels;
- Capacities of young civil servants from Bosnia and Herzegovina at all levels strengthened.

### Key performance indicators:

- Frequency of requests received by the EU Delegation for EU Integration Facility assistance from Bosnia and Herzegovina authorities to address specific EU integration requirements;
- % of tender procedures launched and finalised, of IPA funds contracted, of IPA funds disbursed;
- Number of young civil servants from different levels of government having successfully completed the executive training programme.

### ***(2) Assumptions and conditions***

#### *Assumptions*

- Political support to institutions in Bosnia and Herzegovina to participate in the EU integration process is maintained.
- Identification of priority areas for assistance in a timely manner.
- Sufficient and good quality applications by the potential beneficiaries.
- Good cooperation with all relevant stakeholders established and maintained during implementation.

***(3) Implementation arrangements for the action:*** indirect management with the British Council and direct management by the EU Delegation

#### ***(3)(a) Entity entrusted with budget implementation tasks***

The Component II of this action, the intra-Bosnia and Herzegovina civil servants exchange scheme, will be implemented in indirect management through a delegation agreement with the British Council to be signed in Q1 2019 for an amount of EUR 1 500 000. The British Council will be entrusted with budget implementation tasks, building on its mandate, strengths, presence and valuable previous expertise in the Western Balkans, particularly in implementing a similar scheme, the Young Cells Scheme in Kosovo<sup>3</sup>, as well as a regional executive programme and exchange component for young civil servants from the Western Balkans in 2016-2017 and subsequent years. The same will need to be replicated within Bosnia and Herzegovina and its many administrative levels and the British Council is the body that has this unique experience and expertise and is therefore recognised as the most suitable implementing partner for the activities envisaged under Component II of this Action.

#### ***(3)(b) Short description of the tasks entrusted to the entity***

This action will be managed under indirect management by the British Council. The entrusted entity shall be responsible for carrying out all the tasks relating to the

implementation of the action. In particular, the entrusted entity shall be responsible for the contracting, implementation, information and visibility, monitoring and reporting of IPA II activities, and the evaluation thereof whenever relevant, in accordance with the principle of sound financial management, and for ensuring the legality and regularity of the expenditure incurred in the implementation of the programme.

**(3)(c) Essential elements of the action (direct management)**

**Procurement:**

- a) the global budgetary envelope reserved for procurement: EUR 2 900 000
- b) the indicative number and type of contracts: 14-18 contracts (11-13 service contracts, 2-3 supply contracts, 1-2 works contracts)

Objective: To contribute to Bosnia and Herzegovina’s overall progress in fulfilling its obligations for European Union accession.

- b) The essential eligibility criteria: applicants must be EU Member State administrations or mandated bodies.
- c) The essential selection criteria are the operational capacity and the technical expertise of the applicant.

**(1) Description of the Action, objective, expected results and key performance indicators**

Description of the Action: This Action provides support to Bosnia and Herzegovina participation in EU Programmes, through co-financing the costs of the entry tickets for

specific EU programmes. As a result, Bosnia and Herzegovina will actively participate in various EU programmes, such as Horizon 2020, Creative Europe, Erasmus+, Customs 2020, Fiscalis 2020, Europe for Citizens, COSME, Third Health Programme 2014-2020, and Employment and Social Inclusion (EaSI). This Action will further support the EU cooperation with Bosnia and Herzegovina and preparation for EU integration in the areas covered by the EU programmes.

The objective is to ensure participation of Bosnia and Herzegovina in EU programmes by co-financing the costs of the entry-tickets/participation fees in areas such research and innovation, culture and audio-visual activities, education, employment, customs and fiscal policies, competitiveness of enterprises and Small and Medium Enterprises (SMEs), health and civil society.

Expected results:

- Enhanced participation of Bosnia and Herzegovina in European Union Programmes, including increased exchanges with EU Member States;
- Strengthened ownership and responsibility of Bosnia and Herzegovina (including in financial terms) for participation in European Union Programmes.

Key performance indicators:

- Number of Programmes for which an International Agreement has been concluded;
- Participation rates in the respective European Union Programmes;
- Ratio of amount paid for the entry tickets and amount of co-financing of projects that Bosnia and Herzegovina applicants annually receive.

### ***(2) Assumptions and conditions***

*Assumptions:*

- Each institution signatory to an agreement for participation to a Union Programme has earmarked sufficient budget allocation for its annual contributions;
- Agreement signatories establish necessary support systems such as intermediary organisations or helpdesks and contact focal points per programme to support applicants and promote the EU programmes.

***(3) Implementation arrangements for the action:*** direct management by the EU Delegation

### ***(3)(a) Essential elements of the action (for direct management)***

This action will be implemented as a reimbursement of maximum 90% for the entry tickets for the selected European Union Programmes after the entry tickets have been paid, on the basis of an agreement between Bosnia and Herzegovina and the Commission.

***(1) Description of the Action, objective, expected results and key performance indicators***

Description of the Action: The Action will increase general awareness of Bosnia and Herzegovina local communities on EU values and/or EU integration process benefits obtained through support of small/medium size interventions related to the EU integration requirements and/or to EU policies. Furthermore, it will improve learning and living environment in local communities in Bosnia and Herzegovina for targeted population groups such as youth, senior citizens, persons with disabilities and reduced mobility, minorities and other vulnerable groups. The action is expected to increase visibility of EU values and EU assistance in Bosnia and Herzegovina.

The overall objective is to increase the level of positive perception and knowledge of the EU integration process by the population in Bosnia and Herzegovina.

The specific objective is to improve awareness and visibility of the EU by implementing small/medium size interventions in local communities in Bosnia and Herzegovina linked to EU projects and/or EU policies.

Expected results:

- Interventions in local communities' facilities and public areas implemented.
- Various awareness raising /training and promotion activities in local communities implemented.

Key performance indicators:

- Number of local communities' facilities adapted and/or (re)constructed to become more comfortable learning/community environment for school children, youth, senior citizens, vulnerable groups, minorities;
- Number of beneficiaries from local communities' authorities and Civil society Organisations (CSOs) with strengthened skills in terms of mainstreaming of accessibility measures;
- Number of thematic events/trainings/workshops and awareness raising activities in local communities organised and number of beneficiaries from local communities' authorities and CSOs who attended them (e.g. on specific EU *acquis*/directives related topics/EU Strategy for Western Balkan flagship initiatives<sup>4</sup>, etc.);
- Number of media coverage on organised specific community events and awareness raising activities/training in local communities.

***(2) Assumptions and conditions***

*Assumptions*

- % of the population in local communities that is aware of the substance and extent of EU financial support to Bosnia and Herzegovina at local level;

- Population/different social groups (including media community) and institutions at the municipal/local level of Bosnia and Herzegovina recognise the benefits of EU integration process and EU funding opportunities;
- Identification of priority areas and locations for assistance in a timely manner;
- Sufficient and good quality applications by the potential beneficiaries;
- Good cooperation with all relevant stakeholders;
- Implementation of interventions under the Action in cooperation with authorities in Bosnia and Herzegovina;
- Successful completion of prior actions on provision of technical documentation for the works and/or provision of equipment.

**(3) Implementation arrangements for the action:** direct management by the EU Delegation

**(3)(a) Essential elements of the action (for direct management)**

**Grant – Call for proposal (EU4ALL):**

a) Objectives and foreseen results:

Objectives: Positive perception and good knowledge of the EU integration process in Bosnia and Herzegovina. Improved awareness and visibility of EU by implementing small/medium size interventions in local communities in Bosnia and Herzegovina linked to EU projects and/or EU policies.

Foreseen results: Interventions in local communities' facilities and public areas implemented. Various awareness raising /training and promotion activities in local communities implemented.

- b) The essential eligibility criteria are: The eligible applicants will be international organisations or Non-Governmental Organisations (NGOs) or non-profit organisations that have had experience in substantial sub-granting of activities, in working at local community level, and have managed similar size of grant contract as the one subject of this Action.
- c) The essential selection criteria are financial and operational capacity of the applicant.
- d) The essential award criteria are relevance, effectiveness and feasibility, sustainability and cost-effectiveness of the action.

Description of the action: The Action will contribute to higher levels of production of safe and quality food, while preserving the natural resources that agricultural productivity depends upon. This will be achieved by supporting the development of a competitive and viable agricultural sector operating within a properly functioning supply chain and contributing to the maintenance of the rural economy and the quality of life in rural areas. This action will also contribute to the sustainable protection of human, animal and plant health in the agri-food chain by supporting gradual EU *acquis* alignment and ensuring administrative and technical capacity building of relevant institutions, allowing them to regulate and implement policy actions in line with EU requirements and monitor the progress in line with strategic objective.

The overall objective of the action is to modernise the agri-food sector and foster rural economy in Bosnia and Herzegovina.

***(1) Description of the Action, objective, expected results and key performance indicators***

Description of the Action: This Action will support Bosnia and Herzegovina in working towards the fulfilment of its commitments as a signatory of the Anti-Personnel Mine Ban Convention and in the implementation of the 2018-2025 Bosnia and Herzegovina Mine Action Strategy. Mine Suspected Area (MSA) projects will be implemented at a surface of 100 square kilometers through activities of non-technical survey, technical survey and clearance of mine in order to eliminate mine threats in affected communities of Bosnia and Herzegovina.

The overall objective is to contribute to effective implementation of the 2018-2025 Bosnia and Herzegovina Mine Action Strategy

The specific objective is to strengthening the capacity of national mine action authorities and operators as well as to increase the number of mine free municipalities in Bosnia and Herzegovina.

Expected results:

- Targeted Mine Suspected Areas per municipality released;

- Performance of national mine action authorities increased in the targeted Mine Suspected Areas

Key performance indicators:

- Number of mine free municipalities;
- Productivity rate of the supported institutions;
- Number of square kilometres cancelled through non-technical survey;
- Number of square kilometres reduced and cleared through technical methods (technical survey, clearance);
- Number of selected (targeted) vis-a-vis number of released Mine Suspected Areas.

**(2) Assumptions and conditions**

*Assumptions:*

- Revised Mine Action Strategy endorsed by the Council of Ministers in 2018;
- Motivation of Mine Action institutions to achieve the goals of the Mine Action Strategy;
- Good level of communication, planning and coordination of mine action agency and civil protection agencies;
- At least 70% of mine suspected areas are included in the official 2019 list;
- Bosnia and Herzegovina Mine Action Centre will conduct the non-technical survey in a timely manner, coordinated with all state and non-state operators who will be implementing the technical methods (technical survey, clearance).

*Conditions:*

The 40 mine suspected area projects corresponding to an approximate suspected hazardous area of 100 km<sup>2</sup> and a maximum of 20 mine-affected municipalities will be selected from the official demining priority list for 2019. In the event of delays (country wide non-technical survey planned for 2018-2019 not concluded timely, 2019 priority list not containing sufficient number of mine suspected areas/affected municipalities, etc) the 2018 official priority list will be used.

Failure to comply with the requirements set out above may lead to a recovery of funds under this programme and/or the re-allocation of future funding.

**Grant – Call for proposal (EU Support for a Mine Free Bosnia and Herzegovina):**

a) Objectives and foreseen results:

Objective: The objective of this action is to contribute to effective implementation of the 2018-2025 Bosnia and Herzegovina Mine Action Strategy by increasing the number of mine-free municipalities.

Foreseen results: 40 Mine Suspected Areas (MSA) corresponding to an approximate suspected hazardous area of 100 km<sup>2</sup> will be surveyed, cleared and released.

b) The essential eligibility criteria: All organisations which are accredited in Bosnia and Herzegovina to conduct demining and have demonstrated experience with land release projects could be eligible to implement part of this action.

c) The essential selection criteria are financial and operational/technical capacity of the applicant.

d) The essential award criteria are relevance, effectiveness and feasibility, sustainability and cost-effectiveness of the action.

e) The maximum possible rate of EU co-financing for grants under this call is 90 % of the eligible cost of the action. The maximum possible rate of EU financing may be up to 100% of the total cost of the action in accordance with Article 190 of Financial Regulation if full funding is essential for the action to be carried out. The necessity for full EU funding will be justified by the responsible authorising officer in the award decision, in respect of the principles of equal treatment and sound financial management.

#### **4 PERFORMANCE MONITORING ARRANGEMENTS**

As part of its performance measurement framework, the Commission shall monitor and assess progress towards achievement of the specific objectives set out in the IPA II Regulation on the basis of pre-defined, clear, transparent measurable indicators. The progress reports referred to in Article 4 of the IPA II Regulation shall be taken as a point of reference in the assessment of the results of IPA II assistance.

The overall progress will be monitored through the following means: a) Result Orientated Monitoring (ROM) system; b) IPA II Beneficiaries' own monitoring; c) self-monitoring performed by the EU Delegations; d) joint monitoring by DG NEAR and the IPA II Beneficiaries, whereby the compliance, coherence, effectiveness, efficiency and coordination in implementation of financial assistance will be regularly monitored by an IPA II Monitoring committee.
