#### THE EUROPEAN COMMISSION,

Having regard to the Treaty on the Functioning of the European Union,

Having regard to Regulation (EU) No 236/2014 of the European Parliament and of the Council of 11 March 2014 laying down common rules and procedures for the implementation of the Union's instruments for financing external action<sup>1</sup> and in particular Article 2(1) thereof,

Having regard to Regulation (EU, Euratom) No 966/2012 of the European Parliament and of the Council of 25 October 2012 on the financial rules applicable to the general budget of the Union and repealing Council Regulation (EC, Euratom) No 1605/2002<sup>2</sup>, and in particular Article 84(2) thereof,

Whereas:

- (1) Commission Decision C(2013) 5048 final adopted on 2 August 2013 approved the programme entitled "Promoting Financial Inclusion through improved governance and outreach of Micro-finance in Jordan". This decision was financed under the European Neighbourhood and Partnership Instrument (ENPI)<sup>3</sup>.
- (2) The purpose of this modifying Decision is to allow for a change in the implementation modalities of this action, in particular to include a grant to the Jordan Micro-finance Network (Tanmeyah) for a maximum amount of EUR 500,000. The Modifying Decision also includes changes in the indicative dates for disbursement of the budget support tranches.
- (3) This Decision complies with the conditions laid down in Article 94 of Commission Delegated Regulation (EU) N° 1268/2012 of 29 October 2012 on the rules of application of Regulation N° 966/2012 of the European Parliament and of the Council of the financial rules applicable to the general budget of the Union<sup>4</sup>.
- (4) The measure provided for in this Decision does not fall in the categories of measures for which the prior opinion of the Committee is required. The European Parliament and the European Neighbourhood Instrument Committee set up by Article 15 of the financing instrument established by Regulation (EU) No 232/2014<sup>5</sup>, which replaced the ENPI Committee set up under Article 26 of Regulation (EC) No 1638/2006, should be informed of this Decision within one month following its adoption,
