The event will bring together Digital Innovation Hubs representatives and regions, with the aim to **address two topics**:

- 1. Bridging supply of results of European Projects on Digital Innovation Hubs with demand of these services by other DIHs and regions**
- 2. Filling the white spots: Upcoming H2020 calls and mechanisms for regions to invest in DIHs**

#### **Bridging Supply and Demand**

Several European projects on Digital Innovation Hubs (DIHs) have developed their own platforms or marketplaces, offering solutions for companies to improve their production processes, products or business models with digital technologies. Although these marketplaces have a high potential to offer useful services to certain companies, it is, due to the often narrow specialisation of the market places, a difficult task to find exactly those matching companies that could use them and to build a sustainable business around the marketplace. One idea that comes to mind is that not every project develops their own marketplace, but that projects join forces and for instance add their outcomes of the project to the marketplace of another project. This will enlarge the scope of the supply side of the marketplace.

On the other hand, regarding the demand side, there are regions where SMEs have certain digitalisation needs but there are no Digital Innovation Hubs that can address these needs. How could these regions stimulate their SMEs to make customers of one of the marketplaces? Some regions are providing vouchers to SMEs that could use to

access one of those marketplaces.

During the day, EU projects will have the opportunity to present their platforms and marketplaces (supply), while regions and Digital Innovation Hubs will showcase examples of how these tools could be re-used and serve other companies (demand). Finally, we will explore the tools and mechanisms that could facilitate demand of solutions to swiftly find matching supply.

## **2. Filling the white spots: Upcoming H2020 calls and mechanisms for regions to invest in DIHs**

Member States and the EU foresee to invest in one Digital Innovation Hub per region through the new Digital Europe Programme. However, at the moment, only around half of all the regions in Europe are covered by hubs. This session will discuss what can be done in 2019 and 2020 to achieve a better geographical coverage.

**11.30-13.00: Session 2 – The role of regional players to foster companies' demand for digital transformation**

European projects are only able to attract a small number of SMEs for their innovation experiments, yet the solutions, platforms and marketplaces developed could benefit many more companies across the EU. Regions, chambers of commerce and other regional actors play an important role in identifying the demand from the SMEs and supporting them in their digital transformation. Therefore, raising awareness on different models to benefit from the different tools and services targeting SMEs can contribute to incentivising the re-use of these solutions and boosting SMEs competitiveness. This session will explore, how regional grants or voucher schemes can be used in this sense, to support new Application Experiments, re-using existing marketplaces or encourage SMEs to connect with highly knowledgeable service providers. This will also help regions optimise the overall mobilisation of their European Structural and Investment Funds (ESIF and in particular ERDF).
