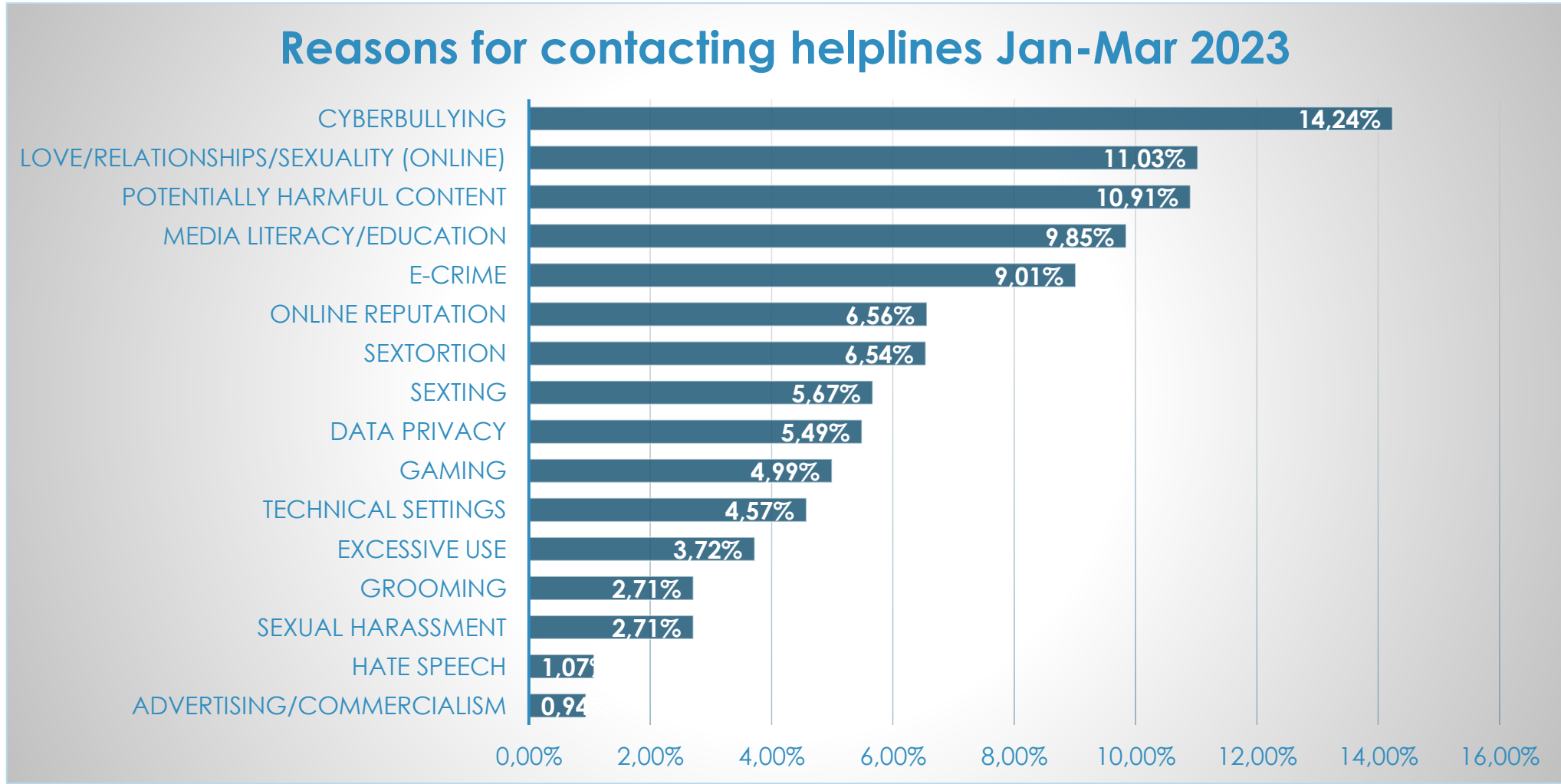

Students are highly engaged on social networking sites, and these sites are used to communicate with existing friendship groups and develop virtual friendships. **Frequent online communication with best friends and bigger friendship groups was associated with higher levels of well-being.** However, the frequency of online contact with virtual friends made online was negatively and significantly associated with well-being with a larger negative association for girls than boys.



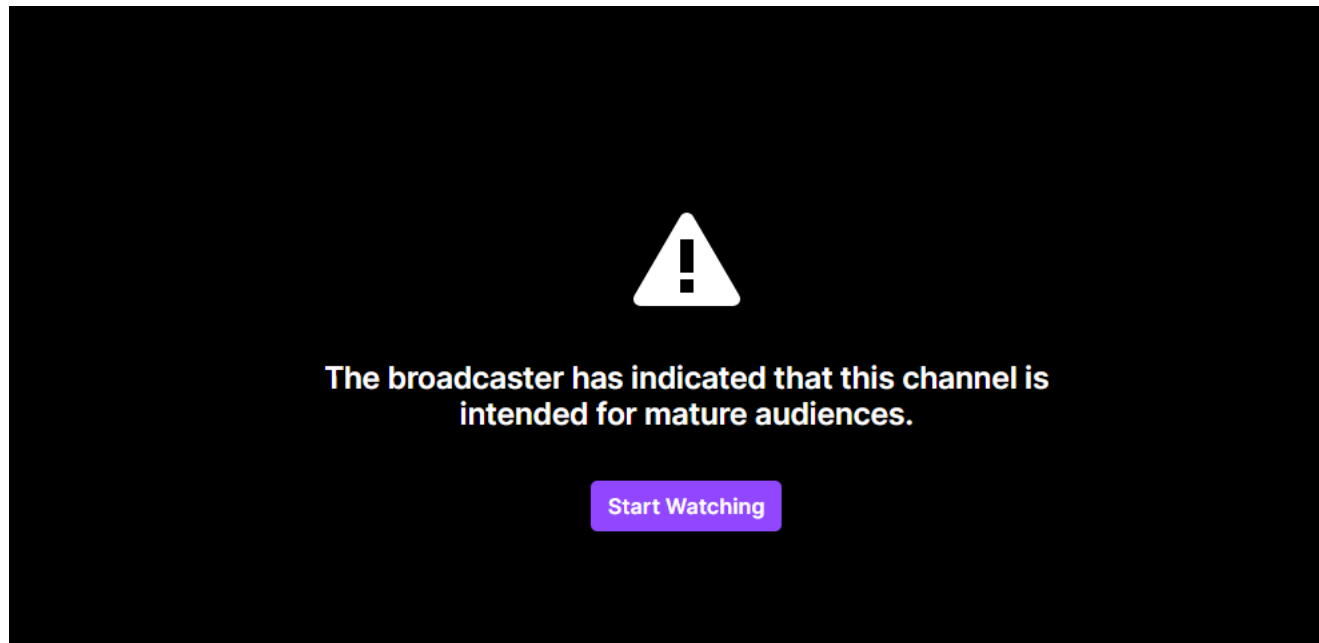

Reasons for contacting helplines Jan-March 2023

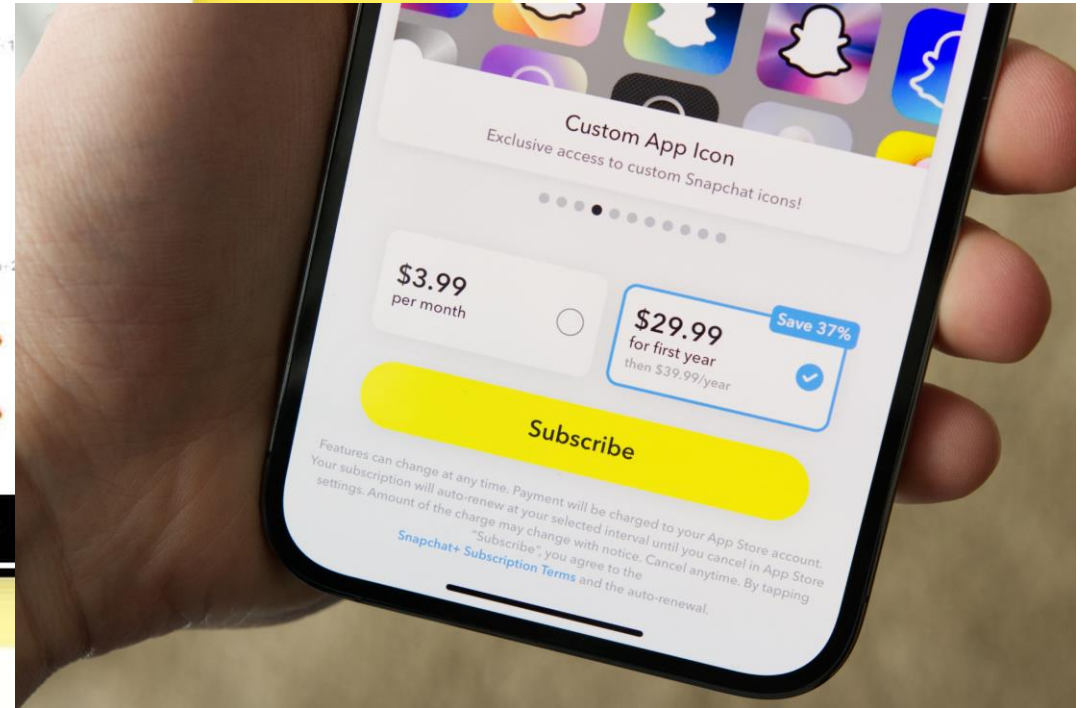
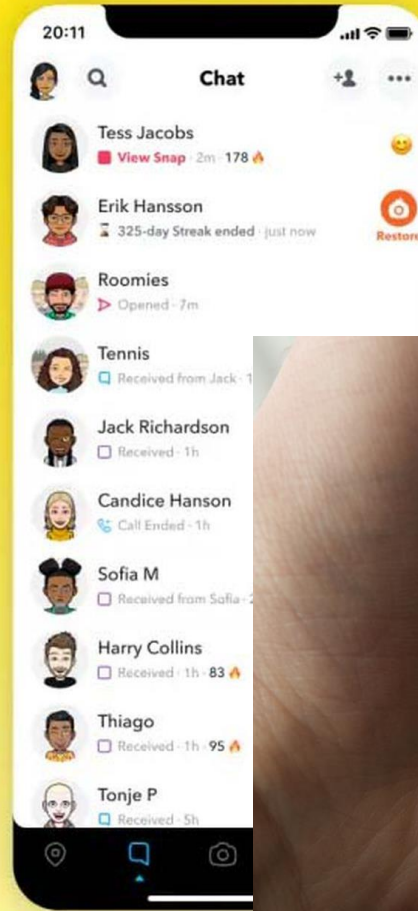
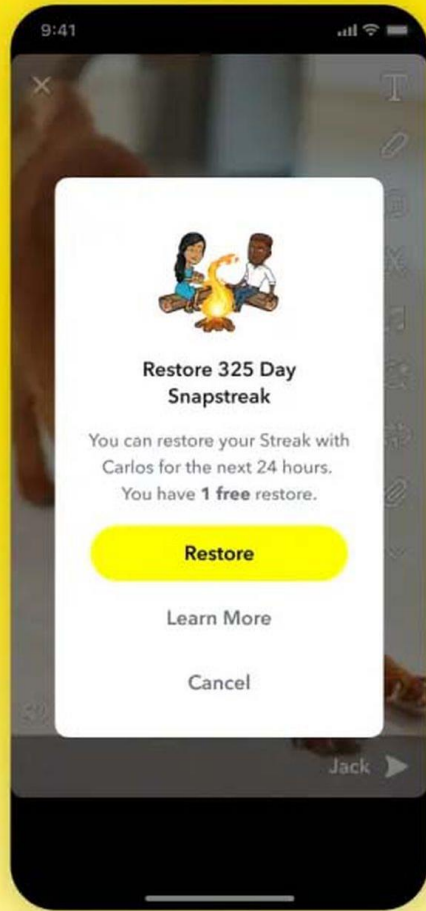


Privacy tools

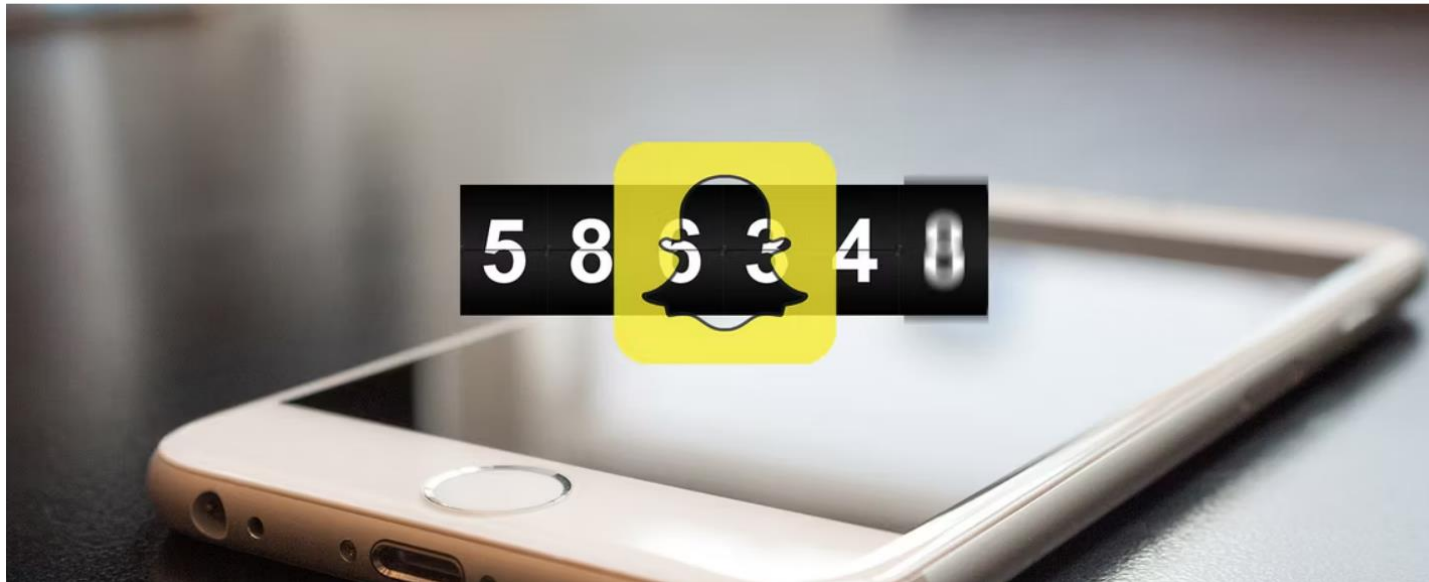

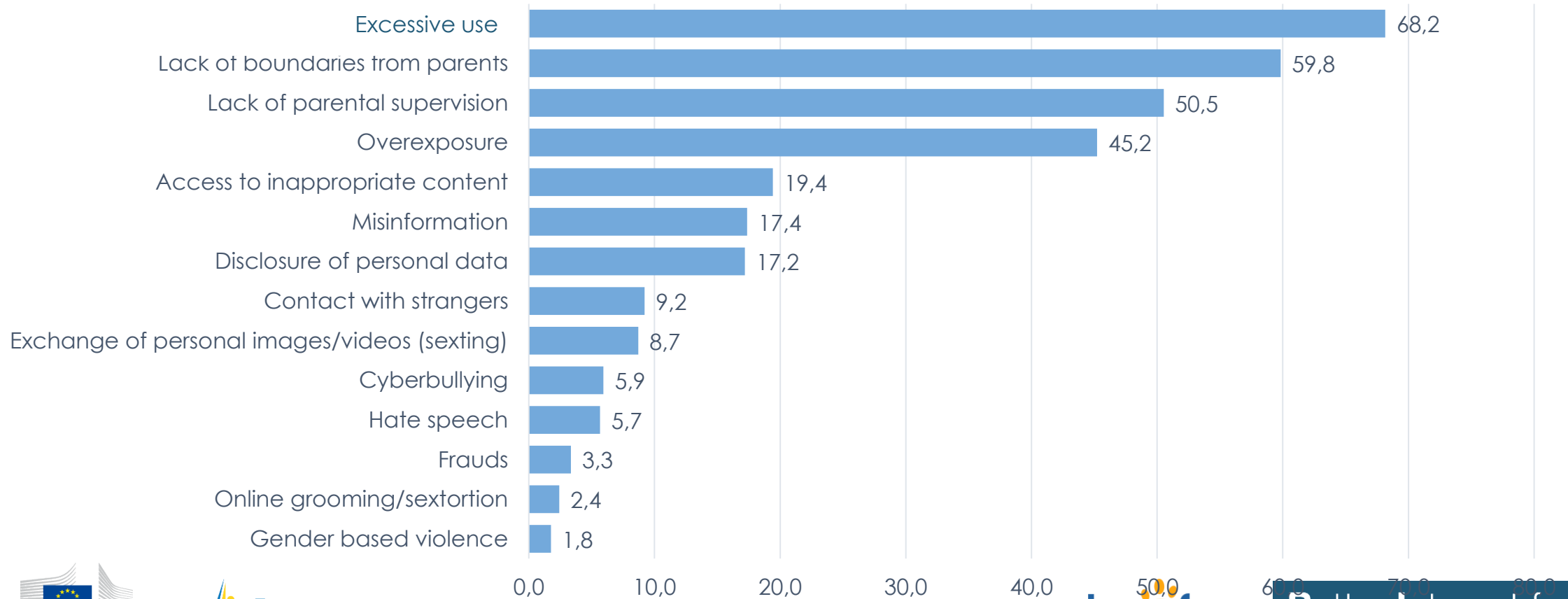

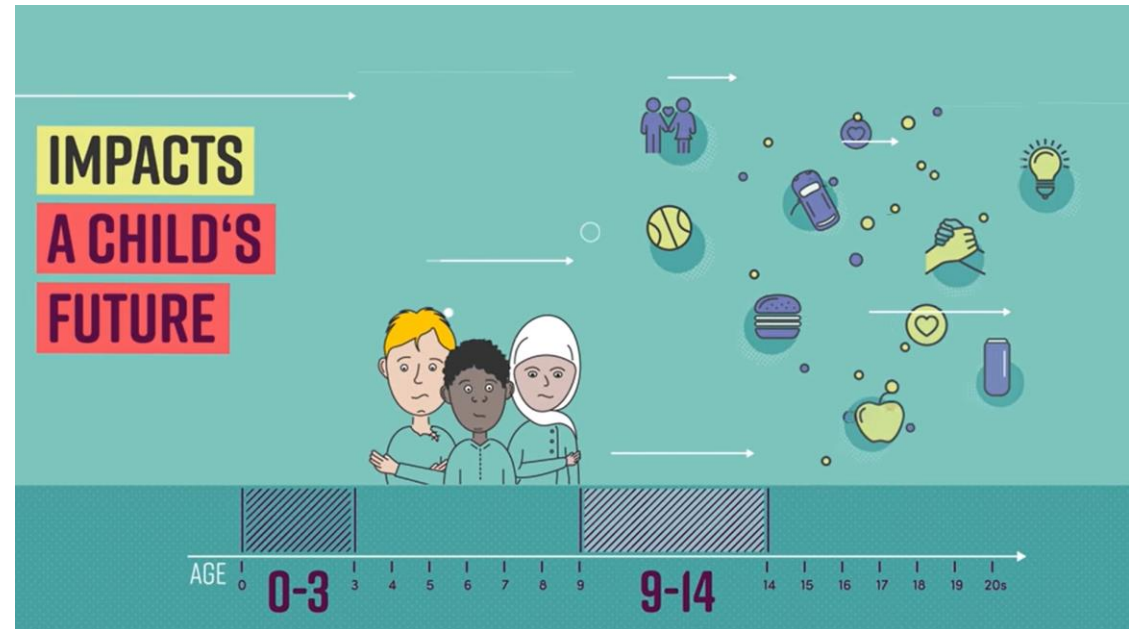
1. Khaby Lama – 161.3 million TikTok followers



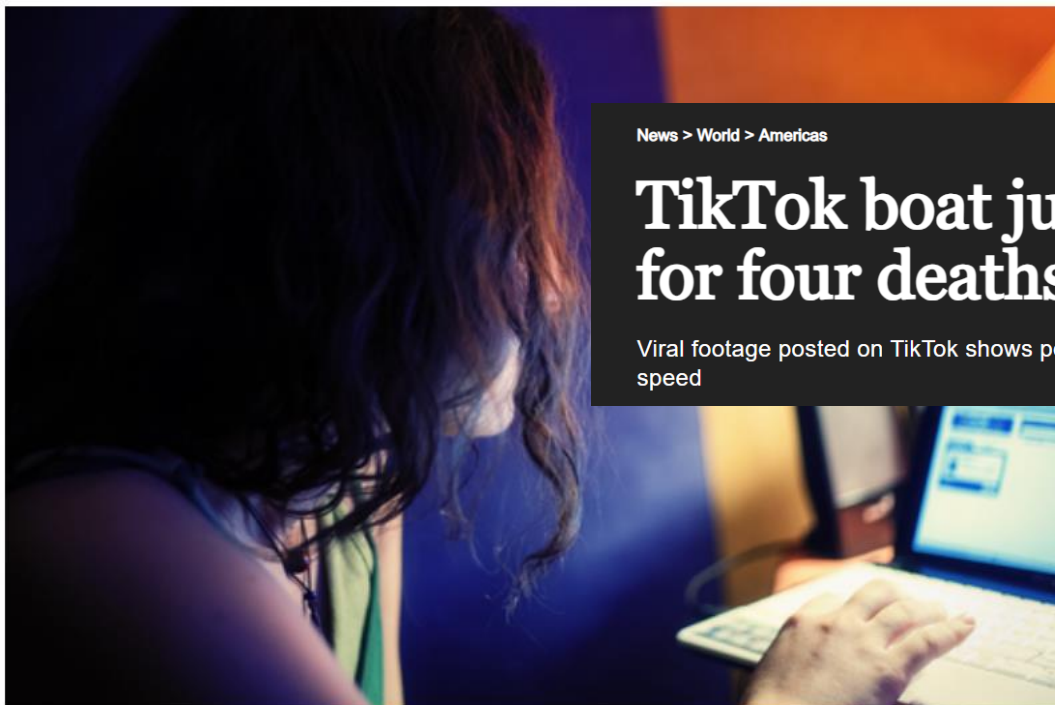
Khaby skyrocketed up through the TikTok top 20 rankings.

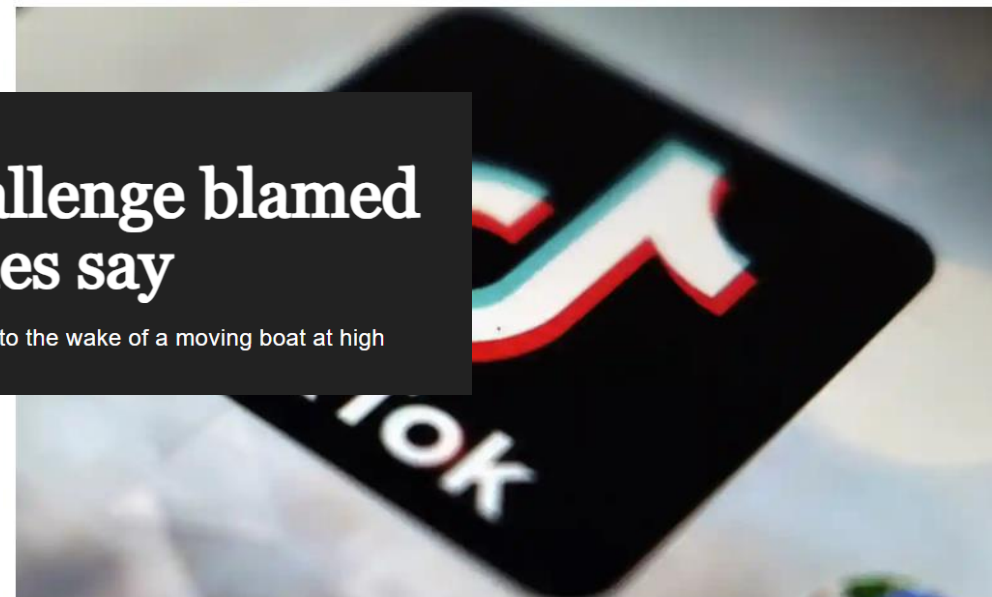

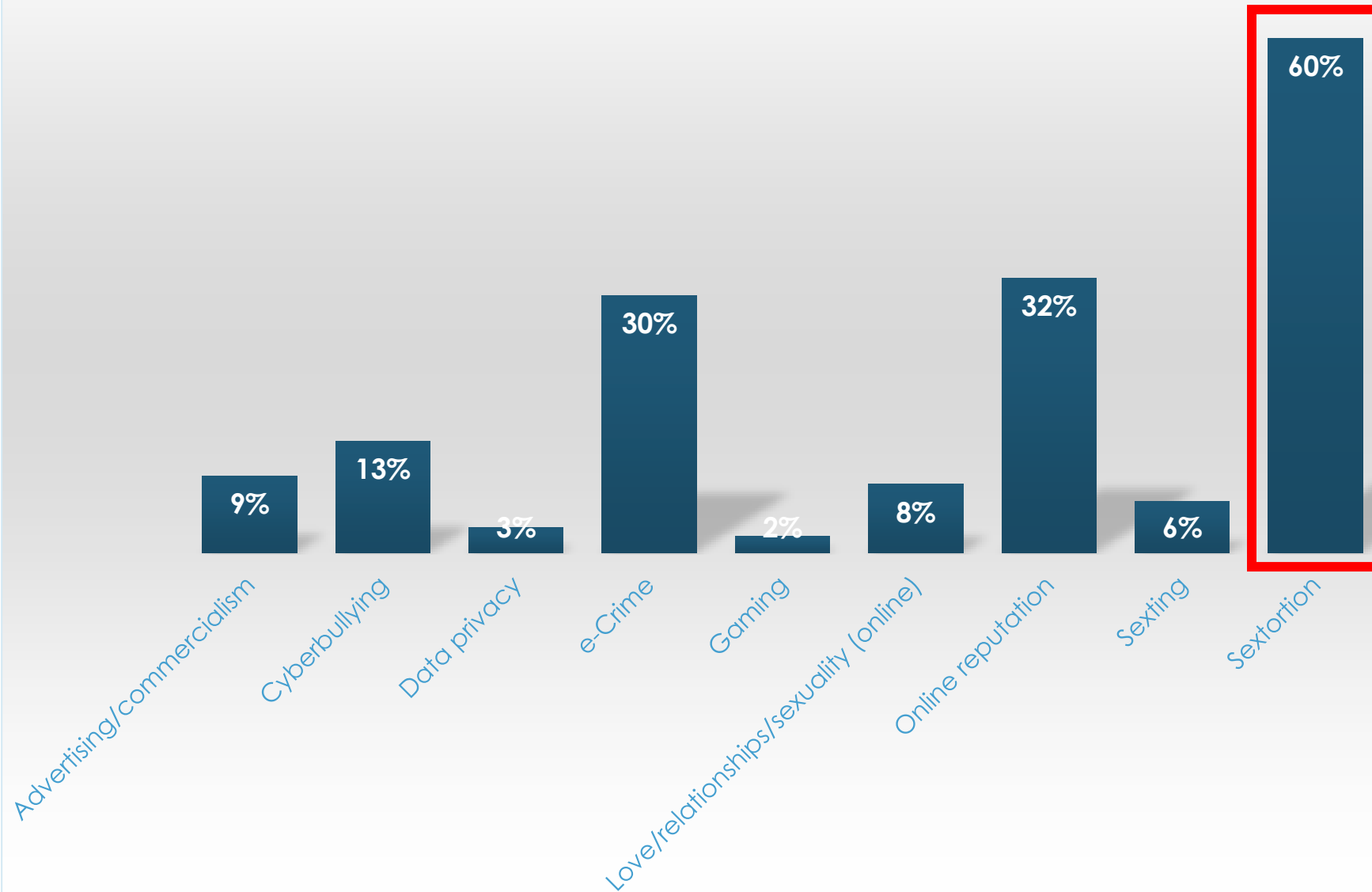



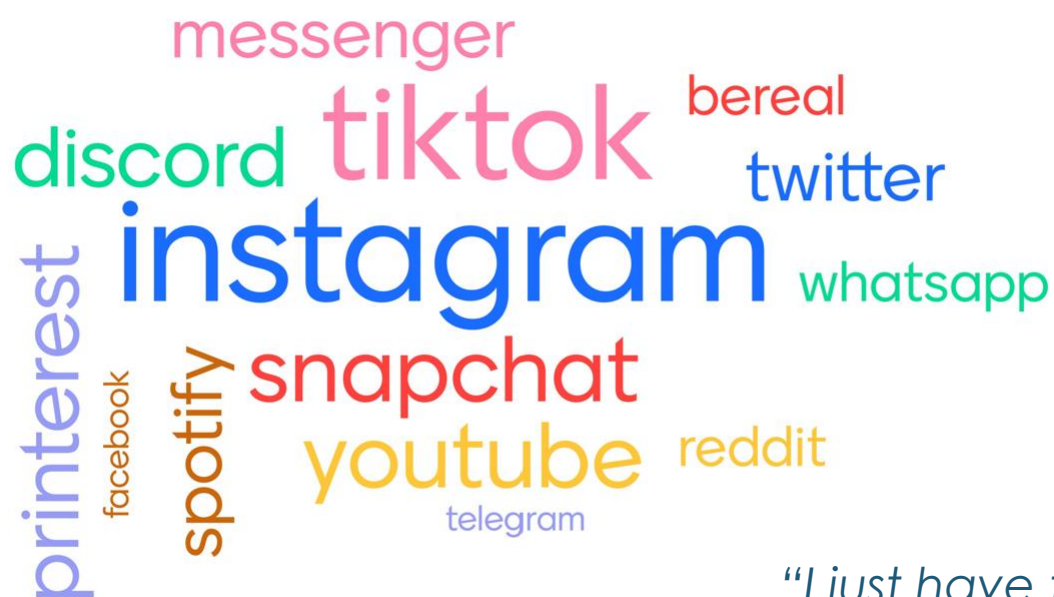
BIK Youth co-creating the Insafe network

- An important sound board and integral part of our and the national Safer Internet Centre's work.
- The BIK Youth Ambassador network currently consists of 40+ engaged and motivated teens and young adults between the age of 14 to mid-20s from across the EU, Norway and Iceland.
- The following input consist of views from 36 BIK Youth Ambassadors from 14 countries, between the ages:
 - 14-15 years old - 5 youngsters
 - 16-18 years old – 21 youngsters
 - 19+ years old – 10 youngsters

Which social media platform/gaming apps are currently your favourite?

*"I currently use no social media platforms or have game apps."
(19 years, Luxembourg)*

*"A lot of children have TikTok and post stuff that is not supposed to be on there but if I report it with my friends, it doesn't do anything. It is really bad that it doesn't work."
(16 years, Estonia)*



*"I just have to, not be a full-on weirdo and because you can't live without it. [...] There's no way around that."
(16 years, Estonia)*

What are the main problems/risks for you and your peers online?

"A lot of content is not age-appropriate yet is not really controlled, lack of awareness regarding data theft, terms & conditions often being too long and boring to read." (15 years, Malta)

"I believe **the main risks come from the lack of knowledge and awareness** from the users, as many of them are related to interactions with malicious people: grooming, cyberbullying, harassment, etc." (17 years, Spain)

"The lack of design for young people. **The internet is not a one size fits all solution.**" (16 years, Malta)

"Internet addiction, misinformation, negativity from **overexposure** to the "perfect social media life" perspective." (18 years, Portugal)



"Anonymous people trying to scam us, or sell us or buy illegal or uncomfortable things (drugs, nudes...) and the **unrealistic expectations that online sets us**, like for example having to look like something specific on social media or having certain things in certain time in our life's to be "good enough." (19 years, Finland)

"I think **the main problem is with informing the youth**: information given about internet safety is often insufficient and contains many gaps. For example, I know my digital footprint exists and that data is recorded online, but how do I make sure my digital footprints are protected, or how do I avoid encountering dangers on the internet? [...]" (17 years, Cyprus)

What commitments/action is needed?

*“**Transparency** from the service providers about the potential side effects of use. Proper controls to minimize the side effects.” (26 years, Portugal)*

*“**News industry** could give **more space for good happenings** in the world as well, it doesn't have to take the space away from the other things to add something good. Social media platforms could pay more attention to bots and scams [...]” (19 years, Finland)*

*“We need strong policies that assure that the interests of the people, specially minors, are the main focus, even over companies' profit. This is why governments should make sure that the **safety of vulnerable people is the number 1 priority.**” (17 years, Spain)*

*“**More reliable age verification and keeping in mind children and young people when designing platforms.**” (16 years, Malta)*

*“**More youth participation**, faster and more effective decision-making processes.” (17 years, Malta)*

*“**Stricter age verifications and get better at removing inappropriate posts.**” (15 years, Norway)*

*“Test some actions on small representative groups before making changes - **include young people who want to have a say.**” (18 years, Portugal)*

*“Young people, who are the people which use social media the most, must be put at the centre of these industry's agenda and should be catered for. Industry must commit to make their platforms **more child-friendly** and safer and include more checks and balances when it comes what content pops up on the app.” (17 years, Malta)*

*“Raising of awareness, **strict guidelines**, quick ways to delete and report inappropriate content” (17 years, Netherlands)*

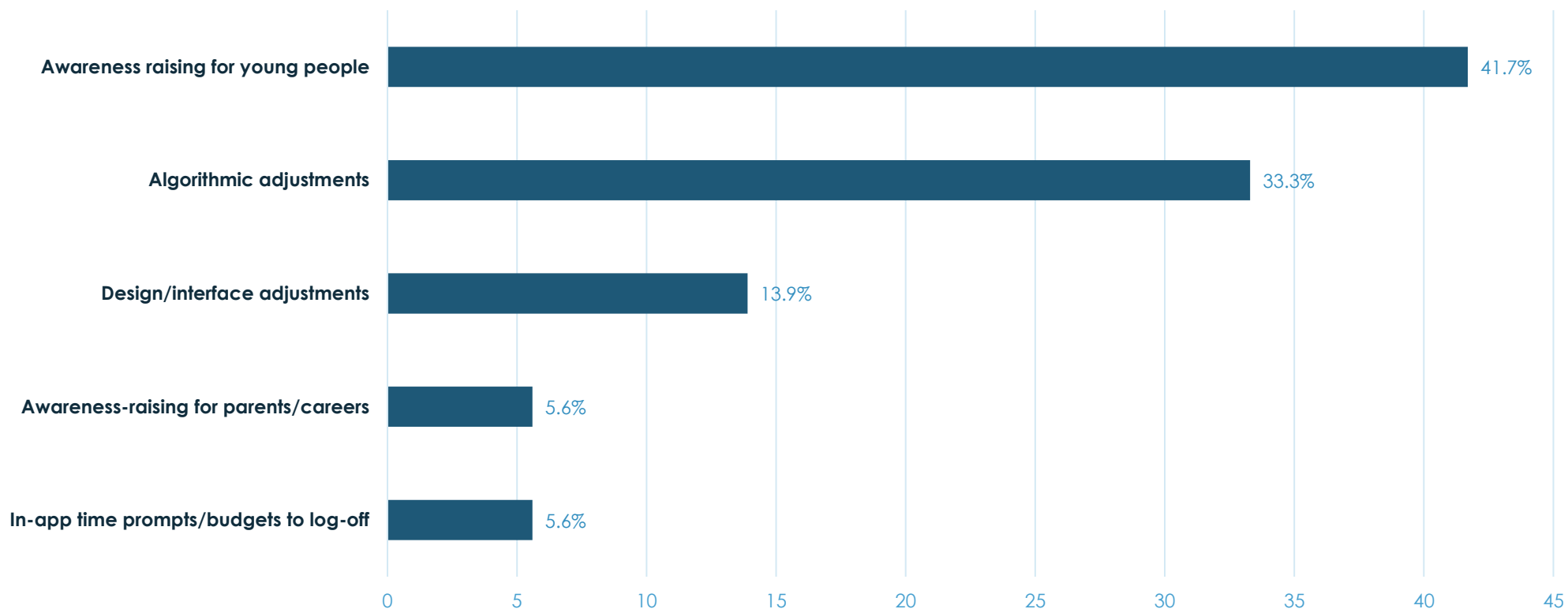
*“More **focus on regulating** comments, videos and pictures. Less focus of benefits for the company (money), more focus on user's well-being.” (19 years, Luxembourg)*

*“**Better filtering on comments and posts.** For example fact checks and **“learn more about this subject” - buttons on posts** that are about sensitive and possibly harmful subjects. The systems for reporting users and the filtering of hateful speech could also be more efficient - especially with less spoken languages.” (16 years, Finland)*

What else?

“Awareness should not just be about cyberbullying, but it should also be about how different videos, photos and content we see might affect us mentally as well as physically.” (17 years, Malta)

“Good effective identification and logging in, information to help what to share and how to deal with scams and bullies and coping with all the bad things and how can I make the online place better, I know pretty much about those already, but someone might not and **there’s never too much information about making online safer and a better place.** “(19 years, Finland)

*“More awareness and education about **young people’s rights online.**” (19 years, Ireland)*

*“Although many major social media platforms have prompts which tell you that it is time to log-off, these have to be switched on by the user and not a lot of people use it, I would make it so that the **log-off button is always turned on** by the social media platform.”(17 years, Malta)*
