This privacy statement provides information about the processing and the protection of your personal data.

Processing operation: Dissemination of information related to the follow up Initiative of the coal regions in transition in the Western Balkans and Ukraine ('EU support to facilitate just transition for Western Balkans regions, industries and workers') and transition period, including via the new initiative electronic newsletter, transitional newsletter (from February until the new initiative referred before starts) and via the subscriber's inclusion in a database of stakeholders on just energy transition in the Western Balkans.

1. Introduction

The European Commission (hereafter 'the Commission') is committed to protect your personal data and to respect your privacy. The Commission collects and further processes personal data pursuant to Regulation (EU) 2018/1725 of the European Parliament and of the Council of 23 October 2018 on the protection of natural persons with regard to the processing of personal data by the Union institutions, bodies, offices and agencies and on the free movement of such data (repealing Regulation (EC) No 45/2001).

This privacy statement explains the reason for the processing of your personal data, the way we collect, handle and ensure protection of all personal data provided, how that information is used and what rights you have in relation to your personal data. It also specifies the contact details of the responsible Data Controller with whom you may exercise your rights, the Data Protection Officer and the European Data Protection Supervisor.

The information in relation to processing operation "Dissemination of information related to the follow up Initiative of the coal regions in transition in the Western Balkans and Ukraine and transition period ('EU support to facilitate just transition for Western Balkans regions, industries and workers'), including via the initiative's electronic newsletter, transitional newsletter (from February 2023 until the new initiative referred before is started) and via the subscriber's inclusion in the database of stakeholders on just energy transition in the Western Balkans undertaken by Unit Western Balkans Regional Programmes, Economic Investment Plan unit (NEAR.D.5) is presented below.

2. Why and how do we process your personal data?

<u>Purpose of the processing operation</u>: Unit Western Balkans Regional Programmes, Economic Investment Plan (NEAR.D.5) collects and further processes your personal data so that you can receive information that you have requested on developments related to the follow-up of the Initiative for coal regions in transition in the Western Balkans and Ukraine ('EU support to facilitate just transition for Western Balkans regions, industries and workers') and transitional period (until this initiative starts), notably activities, events, publications, funding opportunities and other forms of support. In this context, you will receive related and selected newsletters, reports, invitations for events, announcements about energy policy developments, and other similar content. You will also be included in a database of stakeholders on Just Energy Transition in the Western Balkans.

Your personal data will <u>not</u> be used for an automated decision-making including profiling.

3. On what legal ground(s) do we process your personal data

You have subscribed to receive the information on important developments, activities, events, initiatives or thematic issues in the area of the Directorate-General for European Neighbourhood and Enlargement Negotiations and the follow-up program to the "Initiative for coal regions in transition in the Western Balkans and Ukraine" ('EU support to facilitate just transition for Western Balkans regions, industries and workers') and the transitional period (until the start of the project referred before) which will be co-implemented by the European Commission.

We process your personal data, because you have given your consent to the processing of your personal data for the purpose of receiving the requested information.

4. Which personal data do we collect and further process?

In order to carry out this processing operation Unit Western Balkans Regional Programmes, Economic Investment Plan unit of the Directorate-General for European Neighbourhood and Enlargement Negotiations (NEAR.D.5) collects the following categories of personal data:

Mandatory:

 Your name, surname and email address are needed to ensure the delivery of the service to you as a subscriber.

Optional:

- The following personal data is needed for providing you with a more personalised experience (i.e. better targeting the content of the information) and for generating anonymised statistics:
 - Title
 - Function
 - Country of residence
 - Sector of activity / interest
 - Profession

5. How long do we keep your personal data?

The Data Controller, Unit Western Balkans Regional Programmes, Economic Investment Plan unit of the Directorate-General for European Neighbourhood and Enlargement Negotiations (NEAR.D.5) only keeps your personal data for the time necessary to fulfil the purpose of collection, namely until you unsubscribe from the mailing list.

You can write to the functional mailbox <u>NEAR-D5@ec.europa.eu</u> and ask to be unsubscribed from the mailing list. Appropriate action shall be taken within a week of receiving the request.

In case where data is kept for statistical purposes, some subscriber's optional data may be kept for 5 years after the un-subscription, providing these do not allow to identify the subscriber any more and that these are available to a very restricted number of authorised persons performing the processing operation on a need to know basis, for the sole purposes of generating anonymised statistics.

6. How do we protect and safeguard your personal data?

All personal data in electronic format (e-mails, documents, databases, uploaded batches of data, etc.) are stored on the servers of the European Commission or of its contractors. All processing operations are carried out pursuant to the Commission Decision (EU, Euratom) 2017/46 of 10 January 2017 on the security of communication and information systems in the European Commission.

The Commission's processors (contractors) are bound by a specific contractual clause for any processing operations of your personal data on behalf of the Commission. The processors put in place appropriate technical and organisational measures to ensure the level of security, required by the Commission.

In order to protect your personal data, the Commission has put in place a number of technical and organisational measures. Technical measures include appropriate actions to address online security, risk of data loss, alteration of data or unauthorised access, taking into consideration the risk presented by the processing and the nature of the personal data being processed. Organisational measures include restricting access to the personal data solely to authorised persons with a legitimate need to know for the purposes of this processing operation.

7. Who has access to your personal data and to whom is it disclosed?

Access to your personal data is provided to the Commission staff responsible for carrying out this processing operation and to other authorised Commission staff according to the "need to know" principle. Such staff abide by statutory, and when required, additional confidentiality agreements.

The data controller may share your personal data with its contractor for the purpose of managing your subscription to receive information..

Please note that pursuant to Article 3(1) of Regulation (EU) 2018/1725 public authorities (e.g. Court of Auditors, EU Court of Justice) which may receive personal data in the framework of a particular inquiry in accordance with Union or Member State law shall not be regarded as recipients. The processing of those data by those public authorities shall be in compliance with the applicable data protection rules according to the purposes of the processing.

The information we collect will not be given to any third party, except to the extent and for the purpose we may be required to do so by law.

8. What are your rights and how can you exercise them?

You have specific rights as a 'data subject' under Chapter III (Articles 14-25) of Regulation (EU) 2018/1725, in particular the right to access your personal data and to rectify them in case your personal data are inaccurate or incomplete. Where applicable, you have the right to erase your personal data, to restrict the processing of your personal data, to object to the processing, and the right to data portability.

You have consented to provide your personal data to Unit Western Balkans Regional Programmes, Economic Investment Plan unit of the Directorate-General for European Neighbourhood and Enlargement Negotiations (NEAR.D.5) for the present processing operation. You can withdraw your consent at any time by notifying the Data Controller. The withdrawal will not affect the lawfulness of the processing carried out before you have withdrawn the consent.

You can exercise your rights by contacting the Data Controller, or in case of conflict the Data Protection Officer. If necessary, you can also address the European Data Protection Supervisor. Their contact information is given under Heading 9 below.
