Employment and social inclusion

Social cohesion is an important goal of the EU and a major element in the European values expressed in our inclusive social welfare and support systems. Yet many groups of people in the Union suffer from social exclusion, and for different reasons. This extends to employment where some people find it difficult to get a job.

Groups of people can experience social exclusion for many reasons: because they have a physical disability which causes others to doubt their capacities, because they are immigrants who are perceived as being low-skilled compared to others, or because they have health problems that need daily attention. In addition to these are minorities who may be excluded through direct discrimination, for example the Roma and other ethnic groups, older workers and immigrants. All these groups can experience disadvantages, and suffer social exclusion from mainstream society, including employment.

Promoting the full integration and participation of disadvantaged groups of people is a key element of EU policies – and not just employment policies. This is also reflected in the investments planned in the 2007-2013 period. For instance, the importance attached to ensuring gender equality in employment is reflected in the programming for 2007-2013 through two main approaches:

- * Gender mainstreaming, which incorporates the gender dimension into all priorities;
- * Specific actions aimed at getting women into work and sustaining them there, support mainly by the ESF.

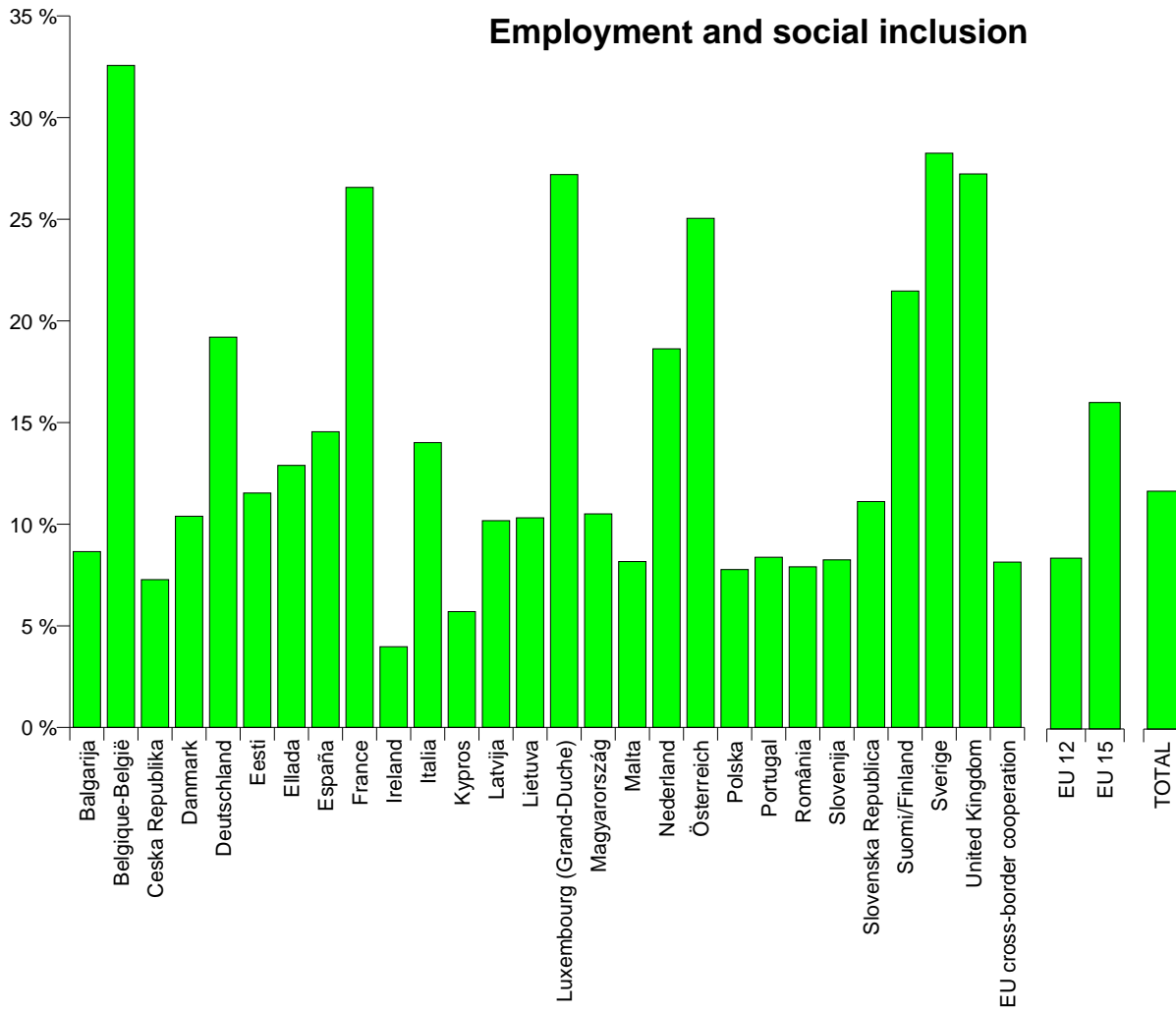
