Introduction

During the negotiations on the ERDF and Cohesion Fund operational programmes (OPs) for 2007-2013, the Commission recommended the use of 'core indicators' for the main intervention areas, including productive investment and infrastructure. Core indicators can be used to compare and aggregate data across similar programmes, priorities or measures. Reporting on core indicators is not a legal obligation in 2007-2013, as the Member States and the Commission are establishing reporting routines and detecting practical reporting issues. However, Member States and Commission have undertaken to make a particular effort to report against core indicators, so as to improve their accountability in the use of the Funds.

One objective of WPO was the collection of indicator data from the AIRs 2012 and 2013. All indicators information reported by Member States has been quality controlled in multiple feedback rounds, and corrected where necessary, to ensure reliability of the data. When verifying the data, checking for consistency of reporting with EC recommendations (see EC Working Document No. 7¹) was a particular focus of the team.

Based on information reported in the AIRs and from MA interviews, this evaluation has also examined consistency between data communicated to the EC through SFC and information reported in the AIR texts. Deviations between WPO AIRs analysis and the SFC structured database are due to:

- indicators that were dropped by WPO because they were not deemed consistent with EU provisions;
- corrections by WPO of wrong unit of measurements or punctuation errors;
- inconsistent reporting by the MAs, due e.g. to different timing of communicating data through SFC and finalising the AIRs.

The team of national experts corrected many core indicator values during the analysis whenever sufficient and plausible information from AIRs or MAs was available (see also section on data quality).

The dataset at hand reflects the current knowledge on correct programme targets and achievements as of December 2014.

How to filter for values

For quick filtering:

- 1. Click the arrow in the table header of the column you want to filter.
- 2. In the list of text or numbers, uncheck the **(Select All)** box at the top of the list, and then check the boxes of the items you want to show in your table.
- 3. Click **OK**.

The filtering arrow in the table header changes to this icon to indicate a filter is applied. Click it to change or clear the filter.

Filter by specific text or numbers:

- 1. Click the arrow in the table header of the column you want to filter.
- 2. If the column has numbers, click **Number Filters**. If the column has text entries, click **Text Filters**.
- 3. Pick the filtering option you want, and then enter your filtering conditions.

For example, to show numbers above a certain amount, pick **Greater Than Or Equal To**, and then enter the number you have in mind in the adjacent box.

To filter by two conditions, enter filtering conditions in both sets of boxes, and pick And for both conditions to be true, and Or for either of the conditions to be true.

Examples for filter queries

Filter query 1:

- Core indicator 1 'jobs created'
- All German programmes
- Only consistent targets and achievements

First, in column 'B' filter for member state: 'DE'.

Second, in column 'N', filter for the core indicator code '1'.

Third, in column 'S', filter for consistent indicators only. Consistent indicators are tagged with 'yes' in the case the originally reported definition was consistent and "no but corrected by 'WPO' in the case that values could be corrected by WPO.

Filter query 2:

- Core indicator 14 'km of new roads'
- Convergence programmes only
- All targets and achievements no matter whether consistent

First, in column 'E' filter for tag 'CON'.

Second, in column 'N', filter for the core indicator code '14'.

Filter query 3:

- Future indicator 27 'Private induced investment'
- All values across programmes
- Only consistent targets and achievements

First, in column 'O', filter for the future indicator code '27'.

Second, in column 'S', filter for consistent indicators only. Consistent indicators are tagged with 'yes' in the case the originally reported definition was consistent and 'no but corrected by WP Zero' in the case that values could be corrected by WPO.

Filter query 4:

- All programme specific indicators for WP4 'Environm. & Transport IS'
- All values across programmes
- Only consistent targets and achievements

First, in column 'L', filter for the term 'specific'.

Second, in column 'Q', filter for 'Environm. & Transport IS'. Programme specific indicators have not to be filtered by consistency as there are no common definitions.
