

#### **DIALOGUE WITH CPR PARTNERS 2021-2027**

INTERACTIVE WORKSHOPS, WORLD CAFÉ FORMAT (ONLINE)

The purpose of the interactive workshop is to benefit from the knowledge and experience of partners on the application and use of the European Code of Conduct on Partnership in 2014-2020. The participants are divided into four groups based on four guiding questions relating to sustainability, growth, urban/rural dichotomy and disadvantaged communities. The groups are expected to discuss these questions in the breakout rooms assigned to them via the online platform, Teams. The members in each breakout room will select a rapporteur among themselves. This person should be ready to summarise the issues raised, the debate and conclusions drawn by his or her group during the plenary discussion. Members of the group can feed into the discussion other elements on the margins of the key questions (e.g. procedural issues, practical considerations incl. better arrangements for cooperation with partners).

The workshops will be followed by a plenary discussion where each rapporteur will present the findings on each topic addressed.
