Use of health data for clinical validation of a technology and to increase efficiency of healthcare systems

Move forward in the adoption and distribution of new or soon-to-be-approved products for PM.

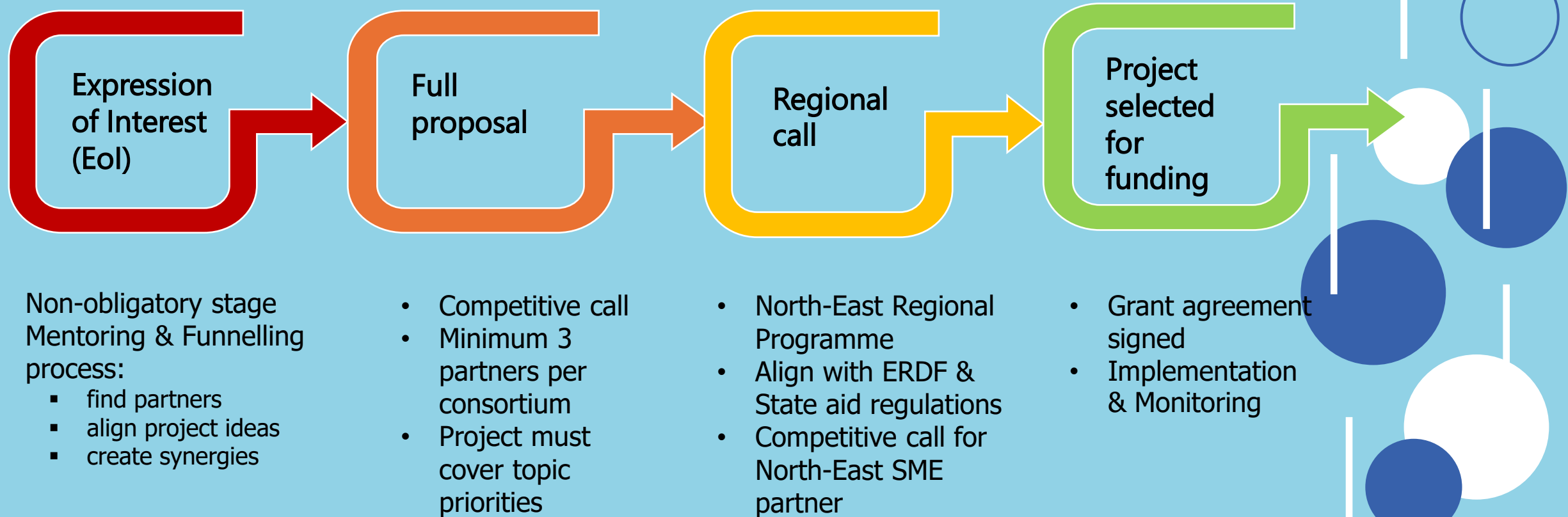
Health equity in technology design to address diverse needs.

Scope: 90% financing for the creation and validation of a prototype model for the innovative solution developed in an interregional partnership, in at least one of the areas of specialization of the North-East Region

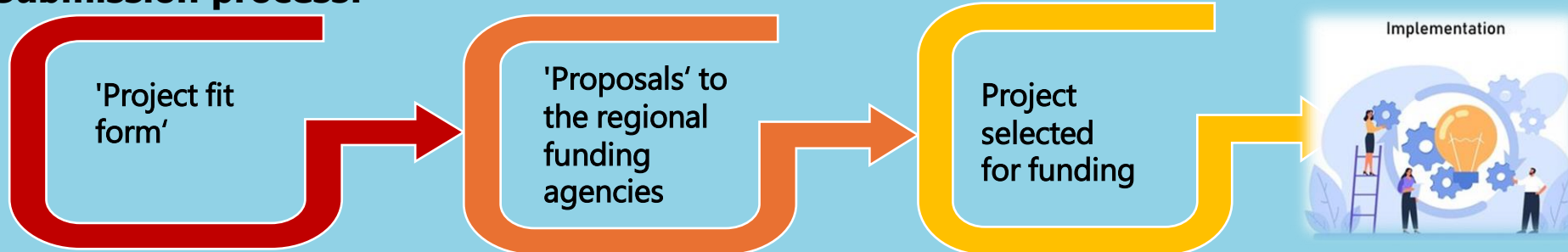
