- Exploit extensive and unique monitoring data held by 4 DGs
- Focus on communication of finances and achievements with structured presentation: [Overview](#) / [Themes](#) / [MS](#) / [Programmes](#) / [Funds](#)
=> not only a data library
- Use new technology to host and make it accessible – visualisations, [API data sets](#), [reusable charts](#), [Data stories](#)
- Maximising level of detail in dataset + timeseries to show progression

Objectives 2/2

- Citizen focused
- Clear and simple language
- Transparency, accountability and performance
- Priority to common elements across funds
- Use catalogue / chart / stories options for more complex issues (i.e. climate tracking, categorisation)

Planned Updates – by end 2020

- Financial data of 30/09/2020 (early December)
- Achievements tiles in absolute values
- NEW Cohesion policy funds aggregation page
- New data stories
(tbc: GHG indicator, Job Creation, Social progress index)

EARLY 2021

- End- 2019 Indicator values + 31/12/2020 categorisation data

Planned developments REACT-EU and 2021-2027

- **REACT-EU** as a new theme page in 2014-2020 period (TBC)
- **Period 2021-2027**
 - Presentation of 2 periods on one site (new landing page)
 - As in 2015 start with (planned)
 - financial tables and categorisation data
 - indicator values, later expanding with implementation data
 - Aggregation of Cohesion policy funds; hosting fund pages for DG AGRI, MARE + HOME (TBC)
 - Publish programmes as adopted vs critical mass (tbc)
