




Transparency International - Bulgaria (Observer) and National Company "Strategic Infrastructure Projects" (Contracting Authority)

Political perspective

✓On 01.03.2024 a Memorandum of Cooperation was signed between the Government of the Republic of Bulgaria and Transparency International Bulgaria.



Policy perspective

✓ Partnership Agreement with Bulgaria on EU funds 2021-2027

<u>Framework conditions:</u> "promoting the implementation of Integrity Pacts in the planning, awarding and execution of public procurement contracts of high public interest and with a significant corruption risk in order to ensure the good financial management of European and national funds".

New art. 237a. Control by observers

The new form of control

The Public Procurement Act Control by observers

Art. 237a. (new - SG 88/2023, in force from 01.01.2024) (1) The Minister of Finance may designate persons to participate as observers in the work of the evaluation committee in public procurement of particular complexity, heightened public interest and/or related to critical infrastructures, and whose values are under Art. 20, par. (above the European thresholds).

- (2) The persons referred to in par. (1) shall have competence in the subject-matter of the public procurement and/or in the application of public procurement legislation, and shall not have a conflict of interest with the contracting authority, the members of the committee and the candidates or tenderers.
- (3) Observers shall prepare a report on their work, which they shall submit to the Minister of Finance and the contracting authority within 10 days of the completion of the work of the commission.
- (4) The terms and conditions for the designation and participation of the observers shall be regulated in the Regulations for the Implementation of the PPL.
