THE EUROPEAN COMMISSION,

Having regard to the Treaty on the Functioning of the European Union,

Having regard to Regulation (EU) No 1303/2013 of the European Parliament and of the Council of 17 December 2013 laying down common provisions on the European Regional Development Fund, the European Social Fund, the Cohesion Fund, the European Agricultural Fund for Rural Development and the European Maritime and Fisheries Fund and laying down general provisions on the European Regional Development Fund, the European Social Fund and the Cohesion Fund and repealing Council Regulation (EC) No 1083/2006, and in particular Article 58(2) thereof,

Having regard to Regulation (EU, Euratom) No 966/2012 of the European Parliament and of the Council of 25 October 2012 on the financial rules applicable to the general budget of the Union , and in particular Article 84(2) thereof,

Whereas:

- (1) On 20 May 2014, the Commission adopted Implementing Decision C(2014) 3166 concerning the adoption of a work programme for 2014 for technical assistance and dissemination of information on the EU strategy for the Baltic Sea Region and an improved knowledge of macro-regions strategy, serving as financing decision.
- (2) Following the mid-term assessment of the work programme, adaptations to the amounts allocated for the different actions should be made.
- (3) To take into account the organisation of the 6th Annual Forum in Latvia in order to continue the good practice of holding the EUSBSR Annual forum to provide a stable platform for debates and progress, results, challenges and solutions for implementation between a wide range of actors at all possible levels, it is appropriate to authorise the award of a grant without a call for proposals to the Ministry of Foreign Affairs of Latvia for the action referred to in the work programme and for the reasons provided therein.
- (4) Implementing Decision C(2014) 3166 should, therefore, be amended accordingly.

HAS DECIDED AS FOLLOWS:

Article 1

The Annex to Implementing Decision C(2014) 3166 of 20 May 2014 is replaced by the Annex to this Decision.
