The Research Executive Agency, assisted by independent experts, has completed the evaluation of the proposals submitted to the above call. The breakdown of evaluation results per topic (also referred to as 'implementation mode') is as follows:

MSCA-IF-2015- EF-ST (European Fellowships-Standard)

Total budget requested from these above-threshold proposals:	950,869,611.6 €

MSCA-IF-2015- EF-CAR (European Fellowships-Career Restart)

Number of proposals submitted:	221
Number of ineligible / inadmissible proposals:	8
Number of proposals receiving an evaluation score above the threshold:	150
Total budget requested from these above-threshold proposals:	26,473,967.5 €

MSCA-IF-2015- EF-RI (**European Fellowships-Reintegration**)

Number of proposals submitted:	586
Number of ineligible / inadmissible proposals:	9
Number of proposals receiving an evaluation score above the threshold:	469
Total budget requested from these above-threshold proposals:	79,955,920.35 €

MSCA-IF-2015- GF (**Global Fellowships**)

Number of proposals submitted:	1,004
Number of ineligible / inadmissible proposals:	20
Number of proposals receiving an evaluation score above the threshold:	796
Total budget requested from these above-threshold proposals:	186,711,956.80 €

Applicants were recently informed about the evaluation results for their proposals.

The number of proposals that can finally be funded depends on the available budget and the formal approval of grant agreements by the Research Executive Agency.

It is expected that the first grant agreements will be signed by March 2016.
