#### How to interpret this table

The percentage of proposals with a given score or higher is shown, per ranking list. Green shows the funding range.

#### For example:

- -in the CHE ranking, 6.63% of all proposals submitted in the ranking list (total 166) scored 96 or higher. The funding cut off is between 95 and 96.
- -in the ENG ranking, 4.78% of all proposals submitted in the ranking list (total 418) scored 95 or higher. The funding cut off is between 94 and 95.
- -in the SOC ranking, 14.07% of the proposals scored less than 70.
