**COMMUNICATION TO THE MEMBERS OF THE COMMISSION**

**concerning**

**the mid-term review of the Commission Legislative and Work Programme 2006**

Communication from President BARROSO  
in agreement with Vice-President WALLSTRÖM

In October 2005, the Commission presented its Legislative and Work Programme for 2006<sup>1</sup>. Based on the strategic objectives defined by the Commission at the start of its mandate (prosperity, solidarity, security, and making Europe a world partner), the programme sets out the priorities that will guide the Commission's efforts to turn the strategic objectives into reality in 2006. This programme was adopted after an extensive dialogue with the European Parliament and the Council on the basis of the Annual Policy Strategy for 2006<sup>2</sup>. Concentrating, as it does, on some hundred priority activities, it is a reflection of the more integrated and coherent policy-planning process of recent years. Of course it does not reflect the full annual work load of the Commission; the ongoing work of implementing the existing acquis, running common policies and Community funded programmes and other tasks resulting from an evolving political agenda are not reflected here – this Programme is limited to highlighting key new initiatives which the Commission intends to propose during 2006.

To date, the Commission has adopted 37 of the initiatives set out in its work programme (see Annex I). The purpose of these initiatives – which are referred to below - is to give tangible form to the strategic objectives pursued by the Commission:

### *Prosperity*

The Commission has invested much effort in the implementation of the renewed Lisbon strategy, working in close partnership with the Member States to support their national reform programmes. Among many other areas, the Commission has proposed a series of measures to improve the competitiveness of **small and medium-sized enterprises (SMEs)**, which are an essential source of innovation and job-creation. These measures are designed to improve access of SMEs to sources of external finance, especially risk capital, to enable them to start up and develop.

In the **transport field**, the Commission has made a **mid-term assessment** of the implementation of the measures advocated in the White Paper it adopted in 2001<sup>3</sup>, which, while based on the continuation of the measures provided for in the paper, proposes supplementary instruments to promote sustainable mobility. One of these new priorities is the **logistics** of the freight transport chain, work on which was initiated with the Commission's adoption of a communication as the first stage towards an action plan.

In the convergence report it adopted at the request of the Slovenian authorities, the Commission concluded that **Slovenia** had achieved a high degree of economic convergence with the other Member States and proposed that it join the **euro zone** on 1 January 2007. This assessment was followed by a proposal concerning the conversion rate to be applied between the Slovenian currency and the euro.

In a drive to make public services more efficient, an action plan was presented for the IT-based modernisation of the Member States' **administrative systems** by 2010. Consultations were launched with a view to reviewing the regulatory framework for **electronic communications**.

Furthermore, in a bid to encourage more European firms to submit tenders throughout the EU, the Commission presented a proposal designed to improve national **means of redress** available

to firms when they consider a public contract to have been unfairly awarded. Deliberations were begun with all the parties concerned on ways of stepping up the fight against **tax fraud**, and a new generation of **customs and tax programmes** was presented with the aim of improving cooperation between national systems and simplifying their operation.

A further initiative is the **European transparency initiative**, which entails broad deliberations on how transparency in European affairs can be increased, with particular reference to lobbying and information on the beneficiaries of European funds.

### *Solidarity*

In reply to a call made by the European Council of 23 and 24 March 2006, the Commission set out the basis for a **European energy policy** in a Green Paper containing more than 20 proposals for concrete action with the aim of guaranteeing the EU a secure, competitive and sustainable energy supply. A Community strategy for encouraging the production of **biofuels** from agricultural matter was also presented as well as a Community plan for halting the loss of **biodiversity** by 2010. The Commission also adopted a strategy for reducing the impact of **pesticides** on human health and the environment and a proposal for the replacement of the existing legislation on the placing of **plant protection products** on the market.

In the agricultural field, the Commission proposed reforming the common organisation of the **wine market** in order to improve the competitiveness of this sector.

The Commission also adopted a Green Paper **on a future maritime policy** for the Union. The aim is to launch a debate on a holistic approach to the seas and oceans while seeking to strike a fair balance between the economic, social and environmental dimensions in a context of sustainable development.

Following the progress made in laying the legislative basis for the cohesion policy for the period 2007-2013, strategic guidelines for **cohesion** were presented to ensure that the priorities defined by the Community in the area of regional development are reflected in the national and regional development programmes now under negotiation.

The Commission presented a communication on future priorities for combating **illegal immigration** from third countries as well as an initiative designed to ensure greater respect for the rights of the child in the European Union and elsewhere. A Green Paper was presented on greater involvement of civil society in Community **efforts to combat drugs**. In the area of personal law, the Commission launched a debate on the legal questions raised by **matrimonial regimes** in an international context, particularly from the point of view of the conflict of laws and jurisdiction, and proposed a regulation on the law applicable to **divorce**.

Furthermore, a roadmap for **equality between women and men** 2006-2010 was presented with a view to stepping up action by the European Union in six priority fields.

### *Security*

In the field of **Justice and Home Affairs**, the Commission presented its first report on the application of The **Hague action plan** and proposed a method for the **evaluation** of policies in the field of justice and home affairs. The Commission also proposed the adoption of a Community code on **short-stay visas** and proposed the creation of rapid-reaction teams which could be temporarily despatched to a Member State to provide, at its request, technical and

operational assistance in the **surveillance of external borders** in the event of large-scale influxes of clandestine migrants.

In a strategy document on the **security of networks and information**, the Commission gave its backing for an awareness-raising drive to encourage enterprises, individuals and administrative bodies in Europe to take the measures necessary to protect their data and equipment.

The social partners were moreover consulted on the need to incorporate the **ILO Maritime Labour Standards Convention** into European law, in order to afford operators fairer terms of competition, improve maritime safety and upgrade the maritime occupations.

### *Europe as a world partner*

In its monitoring reports on the preparation of **Bulgaria and Romania** for EU accession, the Commission considered that both countries should be ready for accession on 1 January 2007 provided they stepped up their efforts at further reform. In the context of the **European Consensus for development**, the Commission proposed that the Community and the Member States should agree on principles and methods for developing a common approach to **governance** in the area of cooperation with the developing countries. As a follow-up to the EU's strategy for Africa issued by the European Council in December 2005, the Commission presented a new **EU-Africa partnership for infrastructures** designed to facilitate economic growth, trade and regional integration and reduce poverty.

In the context of the European neighbourhood policy, draft national action plans were drawn up for **Egypt** and **Lebanon** in consultation with these countries and forwarded to the Council. Lastly, a new partnership for growth, stability and development between the European Union and the **Caribbean** was presented, as was a strategy for strengthening the partnership with the islands of the **Pacific**.

The Commission's adoption of these 37 initiatives represents a mid-term implementation rate of almost 40%. In implementing its work programme, the Commission has a duty to itself to ensure that all the principles of "better lawmaking" are scrupulously observed, whether it be a matter of external consultations, impact studies or simplification. In particular, 2006 is the first year during which the Commission fully applies the new Impact Assessment Guidelines adopted in June 2005. In some cases this has led to a more lengthy preparation process involving wide consultation and greater use of internal and external expertise. All of this additional upstream work will enrich the subsequent initiatives but also implies the need to extend the originally envisaged deadlines for the submission of the proposals. During the first part of this year, the Commission has also been heavily engaged in the inter-institutional discussions on a number of important pending legislative proposals, such as the Services Directive and the REACH proposal, with a view to ensuring progress in the legislative process. Furthermore, the Commission has been responding swiftly to a fast-moving political agenda, in which actions not envisaged at the beginning of the year have become priority.

Noteworthy advances have thus been recorded beyond the initiatives set out in the work programme, such as the adoption on 10 May last of an ambitious action programme which, drawn up for the benefit of European citizens, sets out twelve proposed measures for making the EU a **Europe of results**. This action plan takes account of the messages received in the context of Plan D and the national debates held during the period of reflection advocated by the

European Council last year. Mention should also be made of the **White Paper on communication**, proposing that communication – as a service to the citizen and an instrument of democracy – should become a fully-fledged policy of the European Union, and of the communication on **Social Services of General Interest** with a view to emphasising their specificity and clarifying existing Community provisions in this area. The Commission also proposed creating a **European globalisation adjustment fund** enabling the Community to help workers who have become unemployed as a result of major changes in the structure of world trade to reintegrate into working life. In the **telecommunications** sector, the Commission decided to present an initiative aimed at increasing transparency in the matter of roaming tariffs for mobile communications.

Moreover, the Commission has taken action in the first half of 2006 in response to international developments, for example in Lebanon and the Palestinian territories, as well as following requests from the other institutions:

- Intensive work was carried out on the negotiation of the **budgetary framework for 2007-2013**, resulting in a new interinstitutional agreement at the beginning of May. Following this agreement, on 24 May the Commission presented a package of more than 30 revised proposals designed to ensure that the new generation of financing programmes would be ready to start on 1 January 2007. In addition, a new Human Rights instrument was brought forward at the request of the European Parliament.
- Major progress was achieved on forging an integrated **European energy policy** in response to the call made by the Heads of State or Government at their informal meeting at Hampton Court last October. Based on the Green Paper presented by the Commission in March, the spring European Council issued the list of measures to be taken, relating to both the internal and external aspects of the energy policy. Following the European Council, the Commission, acting jointly with the Secretary-General of the Council/Union High Representative for the Common Foreign and Security Policy, presented a document entitled “An external policy to serve Europe’s energy interests”. Work is in progress with a view to presenting a strategic review of the European energy policy at the start of 2007.
- The project for the establishment of a **European Institute of Technology (EIT)**, as a new pole of excellence in the fields of higher education, research and innovation, was the subject of a Commission communication in February. In response to a call from the March European Council, the Commission launched a vast process of consultations with the Member States and the organisations concerned. Further details concerning this project, which cannot be dissociated from the Lisbon strategy for growth and employment, were provided in a communication in June. The Commission will present a formal proposal by the end of 2006.
- In response to the request made at the informal European Council at Hampton Court in October 2005, the Commission set out its views on the most appropriate way of **modernising European universities**. The Commission’s ideas were presented in a communication covering the whole gamut of the European universities’ activities: teaching, research and their potential role as a motor for innovation.

At their informal meeting at Hampton Court, the Heads of State or Government agreed that the EU had to **raise the external profile of the European Union’s policies**. As a follow-up to this discussion, on 7 June the Commission approved an analysis document entitled “Europe in the World: Some practical proposals for greater coherence, effectiveness and visibility”. A

communication on EU-Iraq relations was also adopted, and the Commission proposed the conclusion of a stabilisation and association agreement with **Montenegro**, which recently opted for independence.

The rules giving effect to the Commission's rules of procedure stipulate that the Commission may **update its work programme** in the course of the year in order to take account of any recent political developments. This updating, which may be made necessary by important political events, is confirmed in the Framework Agreement on relations between the European Parliament and the Commission (point 30).

The mid-term review of the work programme is an opportunity to assess the state of play and update the programme in the light of the current situation. Annex II to this communication contains a list of items on the work programme which are no longer to be presented in 2006, mainly for the following reasons:

- initiatives for which the interinstitutional context has altered and for which a proposal is no longer appropriate this year;
- initiatives for which the impact assessment has shown that the presentation of a proposal is inappropriate or for which more time is needed to complete the impact assessment;
- association with other initiatives which are structured differently or implemented according to a different timetable.

Annex II also provides a list of initiatives now scheduled for adoption in 2006 and meriting inclusion among the priority initiatives of the work programme as they comply with the criteria of political importance set by the Annual Policy Strategy. These new priority initiatives are a response to recent political developments and each is accompanied by a **justification** concerning its inclusion in the work programme. As promised by the Commission for all the initiatives of its work programme, these new political initiatives will be accompanied by an assessment of their economic, social and environmental impact, including their effects on competitiveness.

The new initiatives which the Commission intends to present concern fields such as **the accession of Bulgaria and Romania**, the reports monitoring whose progress towards reform will be brought forward to September, or **innovation in Europe** for which the Commission will propose a broad-based approach. A report will be produced covering progress made in the area of **better regulation** and the next stages of European Union activity in this field as well as a review of the programme for the simplification of Community legislation. As for security matters, activity in this field will be stepped up with the presentation of an initiative on the protection of **critical infrastructures** as a follow-up to the Green Paper of November 2005<sup>4</sup>. Lastly, the Commission will propose negotiating mandates for the conclusion of association agreements with the countries of **Central America** and the **Andean Community** and will publish a Green Paper on possible options for modernising the Community's **trade defence instruments**.

Furthermore, as the spring European Council is scheduled for an early date in 2007, the Commission intends to adopt its annual progress report on the **renewed Lisbon Strategy** before the end of the year, in order to give the Council and the European Parliament enough time to examine this contribution from the Commission before the European Council takes place.
