### TACKLING YOUTH UNEMPLOYMENT IN THE EU

The Commission is today presenting its initiative *Investing in Europe's Youth*, outlining measures to boost youth employment, improve and modernise education, more investment in skills of young people, and better opportunities to learn and study abroad.

#### **KEY FIGURES**



**1.6 million less** young unemployed in the EU since 2013



900,000 less young people not in employment, education or training since 2013

## THE EU INVESTS IN OPPORTUNITIES

Tackling youth unemployment is mainly a task of national governments. But the European Union can support their efforts, and does so in several ways, by creating education and employment opportunities.

#### YOUTH GUARANTEE

Quality offer of employment, education, traineeship or apprenticeship for all young people under 25.

**9** million young people took up an offer under the Youth Guarantee scheme

#### YOUTH EMPLOYMENT INITIATIVE

Main financial instrument to give a boost to the implementation of the Youth Guarantee in regions where youth unemployment reaches more than 25%.

◆ So far, the EU contributed **€6.4 billion** under the Youth Employment Initiative and is planning to increase this funding by another **€2 billion until 2020** 

#### THE ERASMUS PROGRAMME

Thirty years ago, the Erasmus programme was launched, emblematic of what the EU can and should do for youth and solidarity across Europe.

#### **ERASMUS+**

Opportunities for all young Europeans to live, study, volunteer and develop their skills in another Member State.

- 1.3 million young people have benefitted in 2014 and 2015
- ◆ The EU provides funding of more than **€2 billion per year** for mobility and cooperation

#### **MOBILITY OF APPRENTICES**

Opportunities for vocational education and training learners to go abroad (as part of Erasmus+).

- 110,000 mobile vocational learners went abroad in 2015
- The EU will support this with up to €1.7 billion for the period 2014–2020

#### **LAUNCHING ErasmusPro**

The Commission is planning to develop a new activity, "ErasmusPro"—Increasing the impact and quality of the mobility experience through new, dedicated work placements abroad. Under this initiative, **another 50,000 mobile apprenticeship placements of long duration (6–12 months)** will become available.

#### OTHER YOUTH EMPLOYMENT AND TRAINING SCHEMES

Business-led schemes **Pact for Youth** and **Alliance for YOUth**, bringing together EU institutions, business, education and youth stakeholders to boost partnerships for youth employability and inclusion; as well as the **European Alliance for Apprenticeships**, an EU initiative to strengthen the quality, supply and image of apprenticeships.

◆ **543,000 training and job opportunities** for 2013–2020

#### **EUROPEAN SOCIAL FUND**

Europe's main financial instrument for supporting jobs, helping people get better jobs and ensuring fairer job opportunities for all EU citizens by investing in human capital.

- Supporting 4 million young people by investing in their skills and training in 2014–2020
- The total ESF budget is **€86.5 billion** for 2014–2020
