Summary of the action

The Commission has published a call for proposals for activities in the field of undeclared work. The main objective of the call for proposals is to complement and add value to the activities indicated in the work program of the European Platform tackling undeclared work. The Nordic countries welcomes this opportunity and has within the work of the platform seen it as crucial to make it possible for specific cross-border projects to take place. It is within the practical work such as cross-border inspections that mutual learning can arise, and best-practices be realized and shared within the platform. This in order to progress the work against undeclared work.

The Nordic countries are very committed to the task of tackling undeclared work. We see it as crucial to establish good collaborations with all EU member states for the success of this, but especially between ourselves due to geographical proximity. The Nordic countries share many of the challenges that can be identified on the European work market today, and facilitating the transition from undeclared work to formal work is one of the most important.

The aim of this proposal is to strengthen already established co-operation within each country through cross-border inspection and mutual learning activities – and by bringing together, highlighting and sharing good practices that can be found. The results are to be evaluated and disseminated to the members of the Platform for Undeclared Work.

Summary of the action

Promoted by a Consortium of 12 organisations (5 co-applicants, 1 affiliate and 6 associates) comprising trade unions, labour inspectorates, employer organisations, regional government, RAISE UP will act as a facilitator for national reforms in the involved EU member and candidate countries, and as a tool for enhanced cooperation, exchange of information and experience, peer learning on implementing, and especially developing evidence based holistic approach to tackle undeclared work. The task RAISE UP assumes is to promote learning and transfer processes across Europe in the identified policy areas: leverage existing holistic and/or integrated policy measures to tackle undeclared work in agriculture, such as the network of quality agricultural work ('rete del lavoro agricolo di qualità') and integrated controls, design better policies and holistic measures and enable mutual learning among RAISE UP project members, their strategic partners and networks and their wider communities regarding best practices and bottlenecks in prevention and deterrence of undeclared work, learning about how practices could be improved through internal and stakeholders' evaluation providing stronger evidence base. Such processes encompass quality and effectiveness improvement of national (and regional) policies through active cross border cooperation across Europe. RAISE UP supports mutual learning on innovative policy measures and practices and their transfer into other regional and national systems, where feasible through cross border cooperation. This is made possible due to the operation of a participatory action driven research worked out by the Consortium members, the organisation of 5 national workshops in Italy, Bulgaria and FYR Macedonia, 3 European workshops, a European level dissemination event, the design evidence based concrete master plans and roadmaps for future actions, the website and online platform with online learning material and events and social media campaign.
