In 2018-2021, IF will continue its fight for the human rights of children and adults with spina bifida and hydrocephalus. In addition to already established work to promote the right of people to European cross-border healthcare, to support the emancipation of young people and valorise their contribution, and to promote the understanding and practical use of the UN Convention on the Rights of Persons with Disabilities, IF will venture into relatively new areas, incl. contributing to the achievement of the SDGs, e.g. SDG3 on good health & well-being (incl. mental health) & SDG16, ensuring the inclusion of people w/SBH in data & decision-making. Of particular importance is IF's research on integrated care for people with SBH of all ages, which will start at the end of 2018 with an extensive study on the availability of SBH care in the European countries and the demands of the European SBH community in this regard. A European conference will culminate this work in 2020 or 2021 to inform policy-makers, healthcare professionals, researchers and bring together IF members & all relevant stakeholders. IF will also attempt to broach the information gap concerning maternal health literacy by rolling out an information campaign on the importance of adequate folic acid intake in the prenatal period, while safeguarding the dignity of people w/disabilities. The campaign will aim to support its members' activities in this area to work towards national policies & increase knowledge & awareness among policy-makers, professionals & the general public. Finally, IF will use its dynamic communication channels to address its members' quest for information about disability rights, useful policies and good practices, and to disseminate information to a wider audience.

## Summary of the action

From 2018 to 2021, EBU and its members will implement activities to foster the development of an inclusive Europe, where blind and partially sighted (BPS) citizens have the same rights and opportunities as other citizens.

We will collaborate with European and national authorities so that BPS persons' rights are fully addressed in any future legislation. EBU will collect good practices on accessibility and draft position papers and responses to EC consultations. Our on-line UNCRPD database will be enriched with additional national legislative provisions, and analytical reports will be delivered.

EBU will reinforce its members' capacities to contribute to the development and the implementation of EU legislation and policies. Our members' leaders will be trained on gender equality while BPS women will be empowered to lead such mainstreaming process within their organisation. Young BPS persons will be accompanied to find a job. Mentoring will be initiated between EU and non-EU organisations. Also, "how to" sheets on campaigning will be produced to help our members promote more efficiently BPS persons' interests when liaising with European and national authorities.

Awareness-raising will be pursued. EBU will select the best EU-level communication initiatives to complement our usual tools (website, newsletter, flash news, social media). Our members will organise UNCRPD information sessions and raise authorities' awareness on accessible voting. A monthly podcast on accessible technologies will also be produced.

Finally, our network will be further strengthened. E-workshops will provide our members' staff and volunteers with a full insight into our work. Young European and national BPS leaders will be identified and trained. National low vision committees and elderly committees will be reinforced. A yearly event will be held so that national experts and leaders can exchange ideas and experiences, thus consolidating EBU's role as the #1 network of BPS persons in Europe.
