10:00 – 12:30	<p><b>Project visits</b></p> <p>Parallel visits to four different organisations. Delegates will be split into four groups according to their target group preferences and project capacity.</p> <p><b>1. Amaro foro</b> <i>Target group 1: Newly arrived EU Citizens</i></p> <p>FEAD counsellors will inform delegates about the situation of newly arrived EU-citizens, especially from Bulgaria and Romania, the challenges they are confronted with in Berlin and what FEAD does to improve their situation.</p> <p><b>2. "Frostschutzengel" plus</b> <i>Target groups: 1 Newly arrived EU-citizens; 2. Homeless people and people at risk of homelessness; 3. Newly arrived citizens and their children</i></p> <p>FEAD counsellors will explain how healthcare and social counselling is provided for newly arrived citizens and homeless people, also in different languages. In three smaller groups, the delegates will then visit three different project locations, a walk-in-clinic, mobile social counselling and the “MOBI” project helping newly arrived citizens and their children.</p> <p><b>3. EU-Fit-In</b> <i>Target group 3: Newly arrived EU-citizens and their children</i></p> <p>The visit will provide an insight into FEAD assistance to newly arrived citizens with families, particularly large ones. In small groups the delegates will be able to visit day-care centres for children, family centres and learn about typical counselling situations.</p> <p><b>4. Wegweiser aus der Ausgrenzung - Guiding the way out of exclusion</b> <i>Target group 2: Homeless people and people at risk of homelessness</i></p> <p>The delegates will learn how the homeless and those in danger of homelessness in Berlin are being assisted by FEAD counsellors and the Department of Social Services. They will also have a chance to hear from a former end recipient and their experience of FEAD assistance.</p>
