#### Summary of the action

The free movement, in Europe is one of the main rights of the EU but at the same time is also a tool that should be better implemented to fight labour market real obstacles. This mobility must be sometimes sustained by financial help especially for young people in order to help 18-35 to overcome difficulties they may encounter when they find a job in another member state.

The unemployment rate in EU28 remains important and in particular that of youths under 25 that is still 22.2% at the end of 2014.

When they choose to recruit a young European citizen companies and especially SME must find some help in order to secure the recruitment and the career of the new recruit in their company.

YfEj-TMS program is especially designed to fill those needs. The practical answer it offers to youth and employers consists in financing travel for a recruitment meeting and/or expenses for moving in another country after founding a work contract, an apprenticeship or an internship.

It also can be used to finance a complementary training for the new recruit helping the company to better integration and to longer employment.

YfEJ is a complementary tool for all actors of the EU Labour market helping them to increase transnational placements and smoothing financial obstacles for European youth and companies for their transnational placements and/or recruitment needs.

The project has been designed very practically. We do not aim at creating new tools but rather at being complementary to the existing system. It must be very easy to implement and must benefit as many candidates and companies as possible.

The project is open to all professional sectors but will focus specifically on 2 sectors where job shortages are important, ICT and health sector. The project is open to all Member states and EEA countries even if it focuses on mobility from and to all the 6 countries represented by the members of the consortium.

#### Summary of the action

Integriert in das Geschäftsmodell EURES und auf der Basis bestehender Kooperationsformate im EURES-Netz wird der Internationale Personalservice der ZAV (IPS) im Rahmen des zur Förderung vorgeschlagenen Pilotprojekts sein Dienstleistungsangebot auf Vermittlung in sozialversicherungspflichtige Praktika ausdehnen. Im Zentrum der Projektarbeit steht die Frage, inwieweit die Vermittlung in berufsvorbereitende Praktika und die Bereitstellung von finanziellen Hilfen für Sprachkurse dazu beitragen kann, Einstellungshemmnisse zu überwinden und den Einstieg in das Beschäftigungssystem zu erleichtern.

Das EURES-Netzwerk wird die operative Basis und Serviceinfrastruktur für die Durchführung der YfEj-Aktion bereitstellen. Das Pilotprojekt setzt dabei auf die bestehenden Infrastrukturen und Kooperationsformate des EURES-Netzwerks und wird allen öffentlichen Arbeitsverwaltungen der EU-28 Länder sowie Islands- und Norwegens die Teilnahme ermöglichen, sofern die Besetzung von Stellen in Deutschland durch Bewerber aus dem Partnerland (incoming) möglich erscheint. An der Kooperation sind insbesondere die Mittragsteller des YfEj-Projektes, die EURES-Mitglieder Spaniens, Frankreichs, Bulgariens, Finnlands, Kroatiens und Zypern beteiligt.
