Gerhard Bosch (Germany) is Professor Emeritus at the Institute for Work, Skills and Training (Institut Arbeit und Qualifikation) and full Professor of Sociology in the University Duisburg-Essen, Germany. He is an economics and sociology graduate from the University of Cologne. His fields of specialisation – on which he has widely published - are: Employment and Labour market policy, Labour Market Regulations, Wages, Working time, Training, Industrial Relations, Welfare State, New technologies and employment. He was member of Member of 8 High Level Experts Groups in Germany and the EU on Information Technologies, Industry 4.0, Older Workers, Equal Rights, Labour Market Regulations and Financing Lifelong Learning.



Priscilla Boiardi (Belgium) is EVPA's Knowledge Centre and Policy Director, leading the research, policy, training and dissemination activities of the association. Priscilla is also an advisor on numerous EC-funded projects and she is part of the OECD Social Impact Investment Experts Group. Priscilla has more than 10 years of research experience, first as a Research Associate at the Vlerick Business School and then as a PhD candidate at the Catholic University of Leuven. She has a strong expertise in research for business and public bodies, both qualitative and quantitative. Priscilla holds a MSc (Hons) in Economics and Management of Public Administrations and International Institutions from the Bocconi University in Milan. She is an Italian national and speaks Italian, English and Spanish.



Antonia Caruso (Italy) is a sociologist working for Roma Capitale-Social Policy Department and chief European Planning Office, Social Innovation and Coodination of Voluntary Actions. She deals with monitoring of European calls for proposals and other sources of financing for the development of social innovation in social services . She is Project manager of social projects financed with European and national funds. She also works for the promotion of volunteering and the national voluntary civil service in social activities.



Sonila Danaj (Austria) is a researcher and project coordinator at the European Centre for Social Welfare Policy and Research. She has worked as a researcher for fifteen years and been involved in projects related to labour migration and labour migrants working life for more than six years. At the European Centre, she has been managing and acting as researcher for three projects on posted workers, namely the Occupational Safety and Health of Posted Workers (POOSH) project, the Posting of Workers in Eastern Europe (EEPOW) project, and the Posting of third country nationals: Mapping the trend in the construction sector (Con3Post), organizing among other things, country workshops and peer reviews and conducting research on their labour market position. She is also a PHD Candidate at the University of Jyvaskyla, in Finland, where she worked as a researcher for the European Research Council funded project 'Transnational Work and the Evolution of Sovereignty' and the Academy of Finland funded project titled 'Industrial Citizenship and Labour Mobility in the EU'. Previously, she has also served as a research consultant for various international organizations and NGOs, such as UN Women, IOM, Open Society Foundation, and Gender Alliance for Development.



Hanne Denoo (Belgium) holds a bachelor's degree in social work and is working since 2005 as a project manager for the Public Centre of Social Welfare and the City of Kortrijk in Belgium. She is responsible for the development and implementation of EU funded projects, with a focus on innovation in social services and local social policy. She is currently managing the EaSI-funded MISSION action, a pilot programme implemented in the Belgian city of Kortrijk to test an innovative outreach approach for the integrated delivery of local services, aimed at the integration of disadvantaged families in the labour market.





Vjačeslavs Makarovs (Latvia) works as Senior Expert at the Department of the European Union's Structural Funds of the Ministry of Welfare of the Republic of Latvia. He was involved in preparation of regulatory framework for implementation of ESF and ERDF in welfare sector (2014-2020 programming period). From 2016 he has been appointed as a representative of Latvia in the European Commission's Employment and Social Innovation (EaSI) programme and member of the EaSI Committee. Currently is responsible for: (1) coordination of the EU financial assistance instruments (programmes) and (2) implementation and monitoring of the ESF and ERDF projects under responsibility of the Ministry of Welfare. Main tasking being following: Provision allocation of funding for public sector project implementation in the field of welfare under the EU's financial assistance instruments (programmes); provision methodology and guidelines for Simplified cost options for the ESF funded projects in the field of welfare; monitoring financial targets of the ESF and ERDF funded projects in the field of welfare.



Moisés Martínez Mures (Spain) is CFO of Ship2B Foundation. The founding purpose of Ship2B is the acceleration and investment of companies with high social impact. Mr. Martínez is in charge of the administrative, legal, economic and financial area of investment vehicles managed by Ship2B. It also reports the financial and impact indicators of investee companies to private and institutional investors.

Her role includes policy development, financial management, liaison for external stakeholders, performance measurement, implementation of practical and manageable services. 

She has a B.A. in Modern history, Economic history and Politics, and a Postgraduate Diploma in Information Management from London, England. Since 2004, employed by Arbetsförmedlingen, the Swedish public Employment Service, as a EURES Adviser working with international placements and information to jobseekers and employers. Since 2013, employed by Arbetsförmedlingen, the Swedish public Employment Service, on a national level as a Project Manager for the Your first EURES job project (TMS-YfEj), as well as for the Reactivate project during 2016-18. Her current responsibilities consist of managing TMS-YfEj including: Consortium members and partners, budget and project progress, the core project team, liaising with the policy officer for the EU mobility projects at the European Commission, ensuring regular reporting and follow up to the Commission.



Teresa Ventin (Spain) is the coordinator at EURES Crossborder Galicia-North Portugal and started the service created in 1998.
