- o Enhancing *transnational cooperation* between competent national authorities, social partners and NGOs concerned with the OSH and labour/working conditions of posted workers
- Improving access to information on decent labour/working conditions and OSH of posted workers
- Providing comprehensive research on OSH-related vulnerabilities of posted workers and regulatory protection in place in nine EU countries
