#### MAIN PROJECT TASKS

- Carry out a review of all 55 business supervisory agencies and prepare individual recommendations for the design of assessment criteria.
- Develop materials for three training courses outlining the principles behind a modern supervisory system; the development of assessment criteria for strategic documents; and the improvement of consultation skills at supervisory agencies. Organise training events for staff at supervisory agencies.
- Implement four annual surveys of business entities to identify the key trends in the business supervision system, as well as the key issues faced by the business sector.
- Carry out 'secret client' evaluation service at one of the supervisory agencies to evaluate the quality of consultations provided to business entities.
- Update the 'Business Supervision Handbook', to be distributed to participants of the training events.

#### Project journey: from conception to delivery

#### INITIAL STAGE

#### **CONTEXT OF THE PROJECT**

In 2009, the Lithuanian Ministry of the Economy, in collaboration with the Ministry of Justice, introduced a reform seeking to optimise the functions of the country's supervisory agencies and increase their efficiency. The motto of this reform – 'The inspector is not a punisher, but a consultant!' – captures the vision behind it, and sets the direction for supervisory agencies to follow.



#### **PURPOSE OF THE PROJECT**

The project aims to increase the efficiency of Lithuania's business supervisory system by: 1) ensuring the development and application of innovative business supervision instruments by supervisory agencies; and 2) improving the skills of staff employed in these agencies. The project contributes to two recent reform initiatives: the scoreboard of business supervisory institutions and the consolidation of business supervisory institutions.

#### MAIN CHALLENGES FACED, AND DIFFICULTIES ENCOUNTERED

The project coordinator, Gita Šematovičiūtė, joined EIMIN in February 2017. When she started working at EIMIN, the Business Supervision Policy Division was under-staffed, and the implementation of some of its activities and projects was behind schedule. Taking over the project and mobilising efforts was no easy task for Gita's team, and several challenges have occurred along the way. The main difficulties have included the need to closely supervise the work of service providers and to overcome the resistance of some supervisory institutions to collaborating.

PROJECT PHASE

#### KEY DEVELOPMENTS AND EVENTS DURING THE IMPLEMENTATION PROCESS

Gita's team began by carrying out procurement procedures. A consulting company had been contracted with the task of reviewing all 55 business supervisory agencies and preparing individual recommendations for the design of assessment criteria. The KPI recommendations prepared for business supervisory agencies, helped EIMIN colleagues working on the Scoreboard to clarify their vision on one of its criteria – performance indicators. The **Scoreboard** is a tool used to assess how successfully the business supervisory institutions implement the methods suggested by EIMIN. The Scoreboard and the project's recommendations have received both positive and negative reactions among supervisory institutions.



#### **KEY RESULTS AND SUCCESS FACTORS**

The main achievement of the project so far has been the **development of recommendations and assessment criteria for the 55 institutions**. These outputs have also contributed to the Scoreboard. In addition, the team prepared materials for the first training course and have begun to carry out the training. The team noted that these training events have already attracted great interest among the supervisory agencies.

### RESULTS, IMPACTS

## (EXPECTED) IMPACT ON BUSINESS, AS WELL AS ON THE ADMINISTRATIVE SYSTEM IN GENERAL

The project is expected to result in enhanced competences among staff working at supervisory agencies. These results will lead to the provision of better-quality services to business entities, and will reduce the administrative burden imposed on businesses by the supervision process. The project is an important step towards improving the overall business environment.



### LESSONS LEARNT: THE ROLE OF ESF FINANCIAL SUPPORT

This ESF-supported project has contributed to the strengthening of the administrative capacities of the better regulation unit at EIMIN, and those of individual business supervisory agencies in Lithuania. The team at EIMIN has learnt the benefits of **having an in-house expert**; the desirability of **reaching agreements with supervisory agencies** regarding their willingness to participate *before* submitting the project application; and have **improved their procurement and project management skills**. The team has also become aware of the opportunities afforded by EU funding to contract top experts on business supervision from the OECD or the Word Bank.

#### **Personal experiences**



'We seek to ensure a comprehensive approach to business supervision.
