## **Context**

The COVID-19 crisis is having a significant impact upon the economy and labour market. Large numbers of workers have been directly impacted by lockdowns, some have begun working remotely including teleworking, unfortunately many have lost their jobs. Certain people employed in essential services have experienced greatly increased workloads in response to the crisis.

Many sectors will be significantly affected, some permanently. Many working practices will change, demand in some sectors will reduce, whilst there will be skill shortages in others as new trends emerge.

PES have a vital role in providing support in response to these developments. They depend upon reliable, up-to-date information so that they can plan services which meet customers' needs in a rapidly changing environment. At the same time restrictions introduced to combat the virus are presenting huge challenges in the collection of data through tools such as labour force surveys.

During the webinar several PES will present examples of online practices which they have introduced to analyse labour market needs and skills requirements. These enable them to assist jobseekers in dealing with the challenge of increased unemployment and the risks from long-term inactivity. Participants will have the opportunity to learn from colleagues' practices, share examples from their experiences, and gain insights which can be applied in their planning.
