What job and training perspectives do you have, whether short-term (for example this Autumn) or long-term (for example over the next couple of years)? Did you change your plans, for example by studying one year more instead of looking for a job? Is the Youth Guarantee helping you to imagine a bright future and if yes why?

3 IMAGINING COMMON SOLUTIONS

What barriers do you face or expect to face in reaching your goals? Do you consider you need support or help from the EU? Does the Youth Guarantee correspond to your needs? If you were Commissioner for Jobs and Social rights, what would you do to improve the situation of youth?

Guillaume KLOSSA will summarise the main outputs of the exchange and **Nicolas SCHMIT** will conclude this first **CIVICO** CITIZENS' DIALOGUE making the link with the EU Recovery Fund, "Next Generation EU".
