(1) Points 1 and 2 of part II are amended as follows:

1. "Introduction

On the basis of the objectives given in the Regulation (EU) No 1296/2013 of the European Parliament and of the Council of 11 December 2013 on a European Union programme for employment and social innovation (EaSI) as amended by Regulation 2018/1046 and amending Decision No 283/2010/EU establishing a European Progress Microfinance Facility for employment and social inclusion, this work programme contains the actions to be financed and the budget breakdown for year 2020 as follows:

- for grants (implemented under direct management) (point 2): EUR 53 741 795

- for prizes (implemented under direct management) (point 3): N/A
- for procurement (implemented under direct management) (point 4): EUR 47 387 549
- for actions implemented under indirect management (point 5): N/A
- for contributions to trust funds (point 6): N/A
- for financial instruments (point 7): EUR 50 395 929
- for contributions to blending facilities (point 8): N/A
- for other actions or expenditure (point 9): EUR 2 325 220

2. Grants

(2) In section II.2. Grants, under point 2.1, the description of activities to be funded is replaced by the following:

"Description of the activities to be funded

Conferences to provide a platform for Member States and relevant stakeholders to exchange information and good practice on European policy priorities, for example in the field of occupational safety and health between labour inspectorates at EU level.

- (3) In section II.2. Grants, point 2.3.6 is deleted.
- (4) In section II.2. Grants, the following point 2.3.6b is inserted:

"2.3.6b Call for proposals: Strengthening the role of social partners in mitigating the economic and social impact of the COVID-19 crisis (2020_04.030201_173)

Priorities of the year, objectives pursued and expected results

In line with Principle 8 of the European Pillar of Social Rights, this call is targeting European and national cross-industry and sectoral employer and trade union organisations and especially the ones mostly affected by the COVID-19 crisis and being in the most vulnerable situation with a view to ensure their activities and to address the employment and social impact of COVID-19 crisis and strengthen the resilience of workers and employers organisations in the context of COVID-19.

The call aims at supporting exchanges and dissemination of good practices, innovative approaches and experience, and mutual learning at European level in order to sustain social dialogue activities in the context of the COVID-19 crisis and at help national social partners in playing their important role in developing and implementing joint responses or contributing to national efforts to protect jobs and support economic recovery strategies.

If possible, there should be a balanced distribution of the grant allocation between employees and employers organisations.

Description of the activities to be funded

The call intends to support sharing good practices at European level based on the work of the national social partners, in particular in relation to:

- promoting and participating in national bi-partite and tripartite social dialogue and collective bargaining to protect jobs and support the economic recovery;

- to fulfilling their role in European social dialogue around the COVID-19 crisis at the crossindustry levels in its different dimensions of information exchange, consultation, negotiation and joint action, in particular in the context of the Commission's priorities and the European Pillar of Social Rights;

- keeping awareness of European social dialogue and improved capacity to participate in it, including in the context of increasing involvement of social partners in the European Semester process and the implementation of the Recovery and Resilience Facility;

- undertaking relevant analytical or training activities;

- continuing the preparation, monitoring, follow-up and/or implementation of joint texts agreed at the cross-industry levels.

Type of applicants targeted by the call

The grants shall be awarded to a consortium of a lead applicant and one or more co-applicants, based on the following eligibility criteria:

- Applicants (lead and co-applicants) must be properly constituted and registered legal entities, having their registered office established in the participating countries of the Progress axis.

Lead or single applicants must be properly established and registered in EU Member States, Norway or Iceland.

- Lead applicants and co-applicants must be social partner organisations at European level (in application of Article 197 of the Financial regulation, social partner organisations without legal personality are also eligible provided that the conditions of the Financial Regulation related thereto are met).
- The lead applicant must be a cross-industry social partner organisation at European level. The lead applicant can represent workers or employers.
