Support the creation of a European resource centre on accessibility with a network of national centres, to increase coherence in accessibility policies and facilitate access to relevant knowledge. This will support Member States in the implementation of accessibility both in relation to the UNCRPD obligations and EU law in relation to the structural, cohesion and recovery funds, while persons with disabilities have been disproportionately hit by the Covid crisis.

5.1. European Batteries Alliance Academy

Implementing entity

The European Institute of Innovation and Technlogy (EIT) is an independent EU body set up to deliver innovation by bringing together leading business, education and research organisations under cross-border partnerships known as Knowledge and Innovation Communities, notably in the field of energy, climate and raw materials. It is thus best placed to launch a programme to support training and fill in the skills mismatch in the area of batteries that is crucial to the green transition.

Objectives pursued and expected results

Europe's emerging battery ecosystem is at the forefront of the green transition as batteries are the key enabling technology for the switch to zero emission mobility and for the energy storage in the power system. The EU's ability to skill workers will be a success factor of the European Green Deal and of the EU economic recovery after COVID-19. REACT-EU is expected to contribute 25% of the overall financial envelope to climate objectives.

The European Batteries Academy will assist Member States in ensuring the quality of skills development in the area of batteries that can be programmed under REACT EU.

Description of the activities to be funded

The European Batteries Alliance Academy will assist Member States in ensuring the quality of skills development in the area of batteries, in particular by extending the learning repository, updating and improving learning resources, building a certification of learning and training programmes and by building the capacities of ESF Managing Authorities.
